## An Ordinance No. 350.

Determining to proceed with the construction of a part of the sewer in sanitary sewer district No. 5. together with a part of a main sanitary sewer in sanitary sewer district No. 4.

Be it ordained by the Council of the Village of Bexley, State

of Chio:

Section 1. That it is hereby determined to proceed with the construction of the part of the sewers provided for in an amended general plan for a system of sanitary sewage in said village, said amended general plan consisting of the creation of an additional sewer district designated as No. 5, adopted by the council on the 25th day of April, 1922, and on file in the office of the village clerk; and also to construct an eight inch main sewer, a part of which is in sewer district No. 4, adopted by the council March 15, 1922, and now on file in the office of the village clerk; and that the portion of the work provided for in said amended general plan which it is hereby determined to construct is as follows:

An eight inch sanitary sewer in the first alley east of Peck Avenue from the first alley south of Main Street to the center of Astor Avenue, and also an eight inch sanitary sewer in the first alley west of Peck Avenue from the first alley south of Main Street to the center of Astor Avenue, together with an eight inch sanitary main sewer in Astor Avenue from the first alley east of Peck Avenue to the first alley east of Eauclaire Avenue; that part of said main sewer in Astor Avenue between the first alley east of Peck Avenue and Roche Avenue, the eastern boundary of sewer district No. 4, being in sewer district No. 5 and the remainder of said sewer in Astor Avenue being in sewer district No. 4.

Section 2. Said sewer shall be constructed of Vitrified sewer pipe and brick manholes with iron covers in accordance with the plans and specifications prepared by the Village engineer and on file in the office of the Village clerk.

Section 3. That the whole cost of constructing said sewer shall be assessed in proportion to the bemefits which may result from said improvement upon the following described lots and lands to-wit: On all of the lots and lands fronting and abutting on the first alley west of Peck Avenue from the first alley south of Main Street to Astor Avenue and upon all the lots and lands fronting and abutting on the first alley east of Peck Avenue from the first alley south of Main Street to Astor Avenue, which said lots and lands hereby are determined to be specially benefitted by said improvement and in an amount equal to the cost thereof.

Section 4. That the assessment so to be levied shall be paid in five equal annual installments with interest on deferred payments at six per centum (6%) per annum, payable semi-annually. Provided, however, if bonds or notes

are issued in anticipation of the levy of special assessments bear a rate of interest less than six per centum (6%) per annum then such deferred payments shall bear the same rate of interest as is borne by such bonds or notes.

Section 5. That bonds of said village shall be issued in anticipation of the levy of special assessments to pay the cost of said sewer and in an amount sufficient to pay the estimate and cost thereof.

Section 6. That the clerk be and hereby is authorized and directed to advertise for bids for the construction of said improvement according to lew.

Section 7. This ordinance shall take effect and be in force from and after the earliest period allowed by 18w. Passed June 27, 1922.
