

AN ORDINANCE NO. 363.

To levy special assessments for the construction of a part of the sanitary sewer in District No. 4, to-wit, in the alley between Cassady Avenue and Ardmore Road.

Be it ordained by the council of the Village of Bexley, State of Ohio:

Section 1. That, to pay the cost and expense of constructing a part of the sanitary sewers in sanitary sewer district No. 4, to-wit:

An eight (8) inch sewer in the alley between Cassady Avenue and Ardmore Road commencing at a man hole in the center of Powell Avenue six (6) feet west of the center line of said alley; thence extending north in said alley and six (6) feet west of the center line thereof to a man hole six (6) feet south of the center line of the first alley south of Broad Street, amounting in the aggregate to \$2159.59 as reported to this council by the engineers of said village, therebe and hereby is levied and assessed upon the lots and lands bounding and abutting upon said improvement and hereinafter described, the several amounts herein set forth, to-wit:

Section 2. That said assessments shall be certified by the

clerk of this council to the county auditor as provided by law, to be by him placed upon the tax duplicate for collection as other taxes are collected; and that said assessments shall be payable at the office of the county treasurer of Franklin County, Ohio, in five (5) equal annual installments with interest thereon at the rate of five and one-half per cent. (5½%) per annum payable semi-annually from October 1st., 1922.

Section 3. That said assessments and all portions thereof when collected shall be applied to the payment of the bonds issued in anticipation of the levy of special assessments for said improvement and the interest thereon as the same becomes due and to no other purpose.

Section 4. This ordinance shall take effect and be in force from and after the earliest period allowed by law.
