## AN ORDINANCE NO. 399.

To provide for the issue of bonds in anticipation of the levy of special assessments for the improvement of Ardmore Road from Broad Street to the north line of lots 705 and 782 of Ardmore Addition No. 2

WHEREAS, the Village Clerk pursuant to the provisions of Sections 2295-7 of the General Code of Chie, has certified to this council that the estimated life of the improvement proposed to be constructed from the proceeds of the bonds hereinafter mentioned, is ten years, and has further certified the maximum maturity of such bonds calculated in accordance with the provisions of sections 2295-9 of the General Code, to be ten years, and

for the payment of said bonds and a tax to provide for any deficiency in the levy or collection of said assessments will first appear upon the duplicate for the tax year 1923, and that the final tax settlement with the County Treasurer next following the inclusion of such tax in the annual budget by the County Auditor as provided by law, will be obtained not earlier than the first day of September, 1924, and will require \$2475.00 for interest until such assessment and taxes are collected and available.

NOW THEREFORE, be it ordained by the Council of the Village of Bexley, State of Chie:

Section 1. That bonds of said Village shall be issued in the aggregate amount of \$45,000.00 for the purpose of raising money in anticipation of the levy and of the collection of special assessments to pay that portion of the cost and expense heretofore as a read assessed for the improvement of Ardmore Road from Broad Street to a ne of lots 705 and 782 of Ardmore Addition No. 2 by grading, curbing and a way with brick, asphalt, bitulithic, tarvia concrete or some other for a improvement, constructing starm sewers necessary to furnish propagate and making water connections therefrom in said road to the lots and a fronting and abutting thereon, in pursuance of Ordinance No. 393, determining to proceed with said improvement passed December 29, 1922, and to provide a fund for the payment of not to exceed one year's interest on said bonds.

Section 2. Said bonds shall be designated as "Ardmore Road Improvement Bonds," and serially numbered from one (1) to forty-five (45), both inclusive. They shall be of the denomination of \$1,000.00 each, bearing date

and opening a subject to the second to the terms

of April first, 1925, and shall bear interest at the rate of five and one-half (525) per cent per annuam, payable semi-ennually on the first day of April and October each year, for which interest coupons bearing the fac simile signature of the Clerk of said village shall be attached to and made part thereofo Said bonds shall fall due and be payable in the order of their serial number as follows. to-wit: Five bends of \$1,000.00 each on the first day of October in each of the years 1924 to 1932, both inclusive.

Solicitor, signed by the Mayer and Village Clerk, and scaled with the scal of the Village of Bexley; they shall express upon their face the purpose for which they are issued, and the fact that they are issued pursuant to law, and this ordinance; they shall be payable, both principal and interest, at the office of the Treasurer of the Village; and shall be issued and sold under the direction of the finance committee of this council.

section 4. That upon the sale of said bends, any premium and accrued interest realized therefrom shall be paid to the sinking fund trustees to be applied to the payment of the principal and interest of said bends. The par value realized from the sale of said bends shall be deposited in the village treasury to the credit of the Ardmore Road north of Broad Street Improvement Fund," and shall be disbursed from said fund on proper vouchers in payment of that part of the cost of the improvement aforesaid, heretofore determined to be especially assessed, for which purpose said money is hereby appropriated.

Section 5. That all installments of said assessments and all portions thereof, together with interest thereon shall be applied to the payment of said bonds and interest as the same become due, and to no other purpose whatever

Section 6. That said bonds shall be full general obligations of said village, and for the payment of the principal and interest of the same, the full faith, credit and revenues of said village shall be and hereby are pledged.

funds to pay the interest and the principal of said bonds premptly when end as they mature, and to create and maintain a sinking fund sufficient to discharge said bends at maturity, there shall be and hereby is levied on all the taxable preperty of said village in addition to all other taxes, a direct tax annually until the maximum date of maturity of said bonds in an amount sufficient to provide for any deficiency in the levy, payment or collection of said assessments as they fall due. That said taxes shall be and hereby are ordered computed, certified, levied and extended upon the tax auplicate and collected by the same officer, in the same manner and at the same time that taxes for general purposes for each year are

certified, extended and collected.

That all funds derived from the tax levies hereby made, shall be placed in a separate and distinct fund, which together with all interest collected on the same and is irrevocably pledged for the payment of the interest and principal of said bonds when and as the same fall due.

Section 8. This ordinance shall take effect and be in force from and after the earliest period allowed by law.
