To levy special assessments for the construction of sidewalks on Parkview Avenue from Main Street to Broad Street.

Be it ordained by the council of the Village of Bexley, State of

Onio:

Section 1. That there be and hereby is levied and assessed upon the lots and lands hereinafter described the several amounts hereinafter set forth, f for the purpose of raising money to pay that part of the cost and expense heretefore described to be levied and assessed for the construction of sidewalks on Parkview Avenue from Main Street to Broad Street pursuant to and in accordance with Resolution No. 158. And it is nereby determined and declared by this council that said lots and lands are each benefitted by said improvement in an amount equal to the assessment nereby levied thereon.

Section 2. That the assessment levied as aferesaid shall be certified by the Clerk of this Council to the County Auditor of Franklin County, Onio, as provided by law, to be by him placed upon the tax duplicate for cellection as other taxes are collected and that said assessments shall be payable at the office of the Treasurer of Franklin County, Onio, in two equal annual installments, with interest thereon at the rate of 500 per centum per annum payable semi-annually from and after the first day of April, 1923.

Section 3. That said assessments and all portions thereof shall be applied to the payment of the bonds issued in anticipation of the levy and of the collection of said special assessments, and the interest thereon as the same become due.

Section 4. This ordinance shall take effect and be in force from and after the earliest period allowed by law.
