

AN ORDINANCE NO. 412.

Determining to proceed with the improvement of Roche Avenue from Main Street to Aster Avenue.

Be it ordained, by the council of the village of Bexley, state of Ohio:

Section 1. That it is hereby determined to proceed with the improvement of Roche Avenue from Main Street to Aster Avenue, by grading, curbing and paving the roadway with brick, asphalt, bitulithic, tarvia, concrete or some other form of permanent improvement; constructing storm sewers necessary to furnish proper drainage for such improvement, constructing a six inch water line with necessary fire hydrants in said Avenue between the points aforesaid, and making water connections therefrom to the lots and lands fronting and abutting thereon in pursuance of Resolution No. 329 declaring it necessary to improve said avenue, adopted on the 21st day of February, 1923, and in accordance with plans, specifications, estimates and profiles for said improvement, heretofore approved and now on file in the office of the village clerk.

Section 2. That all claims for damages resulting therefrom shall be judicially inquired into after the completion of the proposed improvement, and that the solicitor be and he hereby is authorized and directed to institute proceedings in a court of competent jurisdiction to inquire into such claims.

Section 3. That one-half the cost of that part of said improvement between Main Street and Mound Street along property on the west side thereof owned by the Board of Education of said village plus two per cent (2%) of the remaining cost and the cost of intersections shall be paid by said village and the remainder of the cost of said improvement shall be assessed in proportion to the benefits which may result from said improvement upon the following described lots and lands, to-wit:

All lots and lands fronting, bounding and abutting upon the east side of the proposed improvement, between Main Street and Aster Ave. and all lots and lands bounding fronting and abutting upon the west side of said improvement between Mound Street and Aster Avenue which said lots and lands hereby are determined to be specially benefitted by said improvement to the amount hereby determined to be specially assessed thereon.

Section 4. That the assessments so to be levied shall be paid in not less than nine (9) or more than ten (10) equal annual installments with interest upon the deferred payments at the same rate as shall be borne by the bonds to be hereafter issued in anticipation of the levy and of the collection of such assessments.

Section 5. That bonds of said village shall be issued in anticipation of the levy and of the collection of assessments by installments and in an amount sufficient to pay that portion of the estimated cost of said improvement for which the special assessments are to be levied.

Section 6. That the remainder of the cost of said improvement shall be paid ~~from~~ the proceeds of bonds issued by said village in the manner provided by law.

Section 7. That the clerk be and hereby is authorized and directed to advertise for bids for the construction of said improvement according to law.

Section 8. This ordinance shall take effect and be in force from and after the earliest period allowed by law.
