

AN ORDINANCE NO. 433.

By Mr. Frye.

To levy special assessments for the purpose of opening and extending Ardmore Road to Fair Avenue.

Be it ordained by the Council of the Village of Bexley, State of Ohio;

Section 1. That the assessment one half of the cost and appropriating property to open and extend Ardmore Road to Fair Avenue aggregating in amount to the sum of \$2568.60 reported to this council on the 29th. day of May, 1923, by an estimating Board heretofore appointed to report to this council an estimated assessment of one half of said cost and expense upon the lots and lands to be charged therewith notice of the filing of which assessment has been given as required by law, be and the same is hereby adopted and confirmed, and that there be and hereby is levied and assessed upon the lots and lands hereinafter described the several amounts hereinafter set forth, for the purpose of raising money to pay that part of the cost and expense heretofore determined to be levied and assessed for appropriating property to open and extend Ardmore Road as aforesaid, pursuant to and in accordance with ordinance No. 358, determining to appropriate property therein described, passed by this Council on the 22nd. day of August, 1922.

And it is hereby determined and declared by this council that said lots and lands are each benefitted by said improvement in an amount equal to the assessment levied thereon.

Section 2. That the assessments levied as aforesaid shall be certified by the Clerk of this Council to the County Auditor of Franklin County, Ohio, as provided by law, to be by him placed upon the tax duplicate for collection as other taxes are collected and that said assessments shall be payable at the office of the treasurer of Franklin County, Ohio, in eight equal annual installments, with interest thereon at the rate of 5¹/₂% per centum per annum payable semi-annually from and after the first day of April, 1924.

Section 3. That said assessments and all portions thereof shall be applied to the payment of the bonds issued in anticipation of the levy and of the collection of said special assessments and the interest thereon as the same become due.

Section 4. This ordinance shall take effect and be in force from and after the earliest period allowed by law.
