

AN ORDINANCE NO. 442.

By Mr.

To levy special assessments for the improvement of Ardmore Road.

Be it ordained by the Council of the Village of Bexley, State of Ohio:

Section 1. That the estimated assessment of the cost of improving Ardmore Road from Broad Street to the north line of lots numbers 705 and 782 of Ardmore Addition No. 2 aggregating in amount \$42633.55 reported to this Council on the 14th day of August, 1923, by an estimating board heretofore appointed to report to this council an estimated assessment of such cost upon the lots and lands to be charged therewith, notice of the filing of which assessment having been given as required by law, be and the same hereby is adopted and confirmed, and that there be and hereby is levied and assessed upon the lots and lands hereinafter described the several amounts hereinafter set forth, for the purpose of raising money to pay that part of the cost heretofore determined to be specially levied and assessed for the construction of said improvement pursuant to and in accordance with ordinance No. 393, determining to proceed with said improvement passed by this council on the 29th day of December, 1922.

And it is hereby determined and declared by this Council that said lots and lands are each benefitted by said improvement in an amount equal to the assessment hereby levied thereon.

Section 2. That the assessments levied as aforesaid shall be certified by the Clerk of this Council to the County Auditor of Franklin County Ohio, as provided by law, to be by him placed upon the tax duplicate for collection as other taxes are collected and that said assessments shall be payable at the office of the Treasurer of Franklin County, Ohio, in 9 equal annual installments, with interest thereon at the rate of 5% per centum per annum, payable semi-

annually from and after the first day of ^{October} April, 1924.

Section 3. That said assessments and all portions thereof shall be applied to the payment of the bonds issued in anticipation of the levy and of the collection of said special assessments and the interest thereon as the same become due.

Section 4. This ordinance shall take effect and be in force from and after the earliest period allowed by law.

Notice is hereby given that an estimated assessment of the cost of improving Ardmore Road from Broad St. to Maryland Ave., Cassingham Road from Broad St. to Maryland Ave., Remington Road from Broad St. to Maryland Ave., Seneca Park Place from Dawson Ave. to Cassady Ave., Roche Ave. from Main St. to Astor Ave., Bexley Drive from Main St. to C. N. & Z. Traction line, by grading, curbing, and paving the roadway thereof with asphalt, constructing the sewers necessary to furnish proper drainage for each improvement, and constructing water mains and connections in said streets to the inner line of the curb, on the lots and lands benefited and to be charged therewith as set forth in the ordinances providing for said improvements have been made and reported to council and said estimated assessments are now on file in the office of the clerk of the village of Bexley, Ohio, for the inspection and examination of all persons interested therein.
