And it is hereby determined and declared by to a Council that said lots and lands are each benefitted by said improvement in an amount equal to the assessment hereby levied thereon.

Section 2. That the assessments levied as aforesaid shall be certified by the Clerk of this Council to the County Auditor of Franklin County.

Ohio, as provided by law, to be by him placed upon the tax duplicate for collection

as other taxes are collected and that said assessments shall be payable at the office of the treasurer of Franklin County, Chie, in nine (9) equal annual installments, with interest thereon at the rate of 52 per centum per annum, payable semi-annually, from and after the first day of October, 1924.

Section 3. That said assessments and all portions thereof shall be applied to the payment of the bonds issued in anticipation of the levy and of the collection of said special assessments and the interest thereog as the same become due.

Section 4. This ordinance shall take effect and be in force from and after the earliest period allowed by law.
