

RESOLUTION NO. 405. ✓

Declaring it necessary to improve Hartley Road from Bread Street South to Fair Avenue and to repeal Resolution No. 397, "Declaring it necessary to improve Hartley Road from Bread Street South to Fair Avenue", adopted January 8, 1924.

BE IT RESOLVED by the council of the Village of Bexley, State of Ohio:

Section 1. That it is necessary to improve Hartley Road between Bread Street and Fair Avenue in said village, by constructing a six (6) inch water line with necessary fire hydrants therein and making water connections therefrom to the lots and lands fronting and abutting thereon, in accordance with the plans, specifications, estimates and profiles of the proposed improvements prepared by the engineers of said village and now on file in the office of the village clerk, which plans, specifications, estimates and profiles hereby are approved.

Section 2. That the grade of said avenue as improved pursuant to this resolution shall be the natural grade shown by and upon the plans and profiles aforesaid.

Section 3. That the whole cost of said improvement, less one ~~fiftieth~~ ^(1/50) thereof shall be assessed in proportion to the benefits which may result from said improvement upon the following described lots and lands to-wit: All of the lots and lands bounding, fronting and abutting upon said proposed improvement, which said lots and lands hereby are determined to be specially benefited by said improvement and in an amount equal to that part of the cost thereof hereby determined to be assessed thereon.

Section 4. That the assessments so to be levied shall be paid in five equal annual installments, with interest on the deferred payments at the same rate as shall be borne by the bonds to be hereafter issued in anticipation of the collection of such assessments.

Section 5. That said village may borrow money and issue notes due and payable not later than two years from the date of issue, in anticipation of the levy of said special assessments and of the issuance of bonds in anticipation of the collection thereof as provided in Section 3914 of the General Code of Ohio. Said notes shall not exceed in amount that portion of the estimated cost of the improvement for which said special assessments are to be levied.

That bonds of said village shall be issued, in anticipation of the collection of said assessments, in an amount sufficient to pay that portion of the cost of said improvement hereinbefore determined to be assessed upon the property fronting and abutting thereon.

Section 7. That the remainder of the cost of said improvements shall be paid from the proceeds of bonds of said village issued in the manner provided by law.

Section 8. That Resolution No. 397 entitled "A Resolution declaring it necessary to improve Hartley Road from Broad Street South to Fair Avenue", adopted January 8, 1924, be and the same hereby is repealed.

Section 9. This resolution shall take effect and be in force from and after the earliest period allowed by law.

That the cost and expense of such improvement, less one-fiftieth (1-50th) thereof, will be assessed and collected in five (5) equal annual installments in proportion to the benefits which may result from such improvement upon the following described lots and lands to-wit: all of the lots and lands bounding, fronting and abutting upon said proposed improvement from Broad St. south to Fair Ave. of said Hartley Rd.
