That there be and hereby is levied and assessed upon the lets and lands hereinafter described the several amounts hereinafter set forth, for the purpose of raising mency to pay that part of the cost and expense heretofore determined to be levied and assessed for the construction of sidewalks on Main Street from Alum Creek to Roche Avenue, pursuant to and in accordance with resolution No. 371 and 372 to construct said sidewalks adopted by this Council on the 24th. day of July, 1923.
