

AN ORDINANCE NO. 479.

To levy special assessments for the construction of branch storm sewers in Charles Street, Astor Avenue and Mound Street from points opposite the center line of the alley between Roche Avenue and Peck Avenue to the east corporation line of said Village, thence to a township ditch east of the east corporation line.

BE IT ORDAINED by the Council of the Village of Beavley, State of Ohio:

Section 1. That the assessment of the cost and expense of constructing branch storm sewers in Charles Street, Astor Avenue and Mound Street from points opposite the center line of the alley between Roche Avenue and Peck Avenue to the east corporation line aggregating in amount to the sum of \$10,346.99 reported to this Council on the 26th day of February, 1924, by an estimating board heretofore appointed to report to this council an estimated assessment of the cost and expense upon the lots and lands to be charged therewith, notice of the filing of which assessment has been given as required by law, be and the same is hereby adopted and confirmed, and that there be and hereby is levied and assessed upon the lots and lands hereinafter described, the amounts set forth for the purpose of raising money to pay that part of the cost and expense heretofore determined to be levied and assessed for the construction of said branch storm sewers pursuant to and in accordance with Ordinance No. 402, determining to proceed with the said improvement passed by this Council on the 23rd day of January, 1923.
