AN ORDINANCE NO. 535.

To levy special assessments for the improvement of Powell Avenue from Hartley Road to Gould Road by constructing an eight (8) inch water line therein with necessary fire hydrants and connections.

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BEXLEY, STATE OF OHIO:

Section 1. That the assessment of the cost and expense of improving Pewell Avenue from Hartley Road to Gould Road, by constructing an eight (8) inch water line therein with necessary fire hydrants and connections, pursuant to and in accordance with an Ordinance No. 480, determining to proceed with said improvement passed by Council on the 18th day of March, 1924, amounting in the aggregate to Twenty- one Hundred and Fifty Dollars (2150.00) as reported to this council on the 5th. day of September, 1924, by the board heretofore appointed to estimate said assessments, notice of filing of which assessment has been given as required by law, be, and the same is hereby, adopted and confirmed; and that there be, and is hereby, levied and assess d upon the lots and lands bounding and abutting upon said improvement, the several amounts reported as aforesaid, which said assessments, tegether with the description of said lots and lands are as follows, to-wit:

2. That the total assessment against each lot or parcel of paid in cash within thirty days from and after the passage of this each, or at the option of the owner, in five annual installments, with interest the rate of 5% per annum, from November 20th, 1924. All cash payments shall be made to the Treasurer of said Village. All assessments and installments thereof remaining unpaid at the expiration of said thirty days shall be certified by the Clerk to the anditor of Franklin County, Ohio, as provided by law, to be by him placed upon the tax duplicate for collection as other taxes are collected.

Section 3. This ordinance shall take effect and be in force from and after the earliest period allowed by law.
