AN ORDINANCE NO. 563.

Giving permission to Arlis D. Culp, Kathrym R. Skinner, Jennie F. Fullerton and Frederick C. Anthony to construct samitary sewer and water line in the right of way or easement north of Main Street and west of Dawson Avenue.

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BEXLEY, STATE OFF CHIO:

Section 1. That permission is hereby granted to Arlis D. Culp,
Kathryn R. Skinner, Jennie F. Fullerton and Frederick C. Anthony to construct an
eight (8) inch sanitary sewer and water line from their respective premises lying
north of Main Street and west of Dawson Avenue in and through the right of way or
easement heretofore granted to the Village of Bexley by D. P. Cooke, Kathryn R.
Skinner and Frederick C. Anthony in and over the following described premises, to-wit:

1. Beginning at a point located 69.60 feet west of the west line of Dawson Avenue and 176.09 feet south of the south line of Sherwood Road; thence northerly and parallel with Dawson Avenue, 15 feet to a point; thence westerly and parallel with Sherwood Road, 115.50 feet to a point; thence southerly and parallel with Dawson Avenue 7.5 feet to a point; thence easterly and parallel with Sherwood Road and 168.59 feet therefrom, 55.5 feet to a point; thence southerly and parallel with Dawson Avenue 7.5 feet to a point; thence easterly and parallel with Sherwood Road 176.09 feet distant therefrom, 60 feet to the place of beginning.

2. Beginning at a point 127.35 feet west of the west line of Dawson Avenue and 153.59 feet south of the south line of Sherwood Road; thence westerly and parallel with Sherwood Road and 153.59 feet distant therefrom, 57775 feet to a point; thence southerly and parallel with Dawson Avenue 7.5 feet to a point; thence easterly and parallel with Sherwood Road and 161.09 feet distant therefrom 57.75 feet to a point; thence northerly and parallel with Dawson Avenue 7.5 feet to the place of beginning.

3. Beginning at a point located 185.10 feet west of the west line of Dawson Avenue and 153.59 feet south of the south line of Sherwood Read; thence westerly and parallel with Sherwood Read and 153.59 feet distant therefrom, 61.6 feet to a point; thence southerly and parallel with Dawson Avenue 15 feet to a point; thence easterly and parallel with Sherwood Read and 16.59 feet distant therefrom, 61.5 feet to a point; thence northerly and parallel with Dawson Avenue 15 feet to the place of beginning;

Said sewer and water line to be constructed under the supervision of the Syreet Commissioner of Bexley and to extend from the properties of said above named individuals, eastwardly in and over said easement, said sewer to connect with the west terminus of the sewer new extending eastwardly from said easement and said water line to connect with water line in alley extending eastwardly therefrom.

The Village of Bexley nereby reserves a right to extend a like privilege to any other property owner abutting upon said easement or owning property west therefrom, to extend said sewer and water line westwardly for the sewerage of their respective properties; also reserving to said village the right to make necessary repairs to said sewer and water lines.
