## AN ORDINANCE NO. 579.

Determining to proceed with the improvement of Montrose Avenue from Main Street to Charles Street.

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BEXLEY, STATE OF OHIO:

ment of wontrose avenue from Main Street to Charles Street in said Village, by grading, curbing and improving the readway thereof with brick, asphalt, concrete or some other form of permanent improvement, constructing a water line with necessary fire hydrants of such capacity as will furnish water to the properties fronting, or abutting on said improvement, constructing the necessary sewers or drains to furnish proper drainage for such improvement and erecting street signs in pursuance of a Resolution No. 447, declaring it necessary to improve said Avenue, adopted February 10th, 1925, and in accordance with the plans, specifications, estimates and profiles heretofore approved and now on file in the office of the Village Clerk.

Section 2. That all claims for damages resulting from said improvement shall be judicially inquired into after the completion of the improvement and the solicitor hereby is authorized and directed to institute proceedings in a court of Competent Jursidiction to inquire into such claims.

Section 3. Section 4. That the special assessmen to be levied shall be paid in not less than nine nor more than unual installments with interest on the deferred payments at the shall be borne by the bonds to be hereafter issued in antical assessments.

Section 5. Said notes shall not exceed in amount that portion of the estimated cost of the improvement for which said special assessments are to be levied.

Section 6. That bonds of said village shall be issued, in an anticipation of the collection of said assessments, in an amount sufficient to pay that portion of the estimated cost of said improvement hereinbefore determined to be assessed upon the property fronting and abutting thereon.

Section 7. That the village's portion of the cost of said improvement shall be paid from the proceeds of bonds, issued by said village in the manner provided by law.

Section 8. That the Clerk be and hereby is authorized and directed to advertise for bids for the construction of said improvement according to law.

Section 9. This ordinance shall take effect and be in force from and after the earliest period allowed by law.
