AN ORDINANCE NO. 602.

Euthorizing the borrowing of money and the issuing of notes of the Village of Bexley, Onio, in anticipation of the levy of special assessments for the construction of sanitary sewers in part of Sanitary Sewer District No. 4.

BE IT ORDAINED BY THE COUNCIL FO THE VILLAGE OF BEXLEY, STATE OF ORIO:

Section 1. That the Village of Bexley be, and hereby is, authorized to borrow money in the sum of Fifteen Thousand, Six Hundred Dollars (\$\times 15,600.00)\$ and to issue the notes of said Village therefor in anticipation of the levy of special assessments and the issuing of bonds in anticipation of the collection of said assessments as provided by Section 3914 General Code, to pay the costs heretofore determined to be specially assessed for the construction of sanitary sewers in part of Sanitary Sewer District No.4 as follows:

- (a) an eight (8) inch sewer in Charles Street from the present trunk sewer in the first alley west of Euclaire avenue to the first alley west of Roche avenue.
- (b) an eight (8) inch sewer in the first alley west of Montrose avenue from Charles Street to a point 65 feet south of the south property line of the first alley south of Main Street.
- (c) An eight (8) inch sewer in the first alley west of Roche Avenue from Charles Street to a point 25 feet south of the south property line of Astor Avenue.
- Avenue from a point 40 feet west of the west line of hoome avenue; thence westerly to the center line of the first alley west of Roche avenue; thence northerly in said first alley west of Roche avenue to Charles Street, as provided by Resolution No. 442, declaring the necessity therefor, adopted January 27th, 1925, and in pursuance of an Ordinance No. 581, determining to proceed with said improvement, passed March 27th, 1925.

Section 2. That said notes shall be in denominations of One Thousand Dollars (\$1000.00) each, or any multiple thereof, or such smaller denomination as may be necessary, shall be signed by the Mayor, attested by the Clerk, be sealed with the seal of the Village, bear date as issued and shall be use and payable not later than two years from date of issue.

and shall bear interest at the lowest rate obtainable, but not in excess for 5% per annum, payable semi-annually. The proceeds of the bonds issued in anticipation of the collection of the assessments, and all of the assessments collected for said improvement, shall be applied to the payment of said notes and interest thereon until both are fully paid, and thereafter said assessments shall be applied to the payment of said assessments shall be applied to the payment of said honds and interest thereon.

section 3. That the Finance Committee of this Council shall cause said notes to be properly prepared, executed and sold according to law to the person, persons, company or corporation offering the lowest rate of interest, and shall deposit the proceeds in the Village Treasury to the credit of Sundry Sewer Improvement Fund.

Section 4. This Ordinance shall take effect and be in force from and after the earliest period allowed by law.
