Declaring it necessary to improve Dawson Avenue between Maryland Avenue and Ruhl Avenue, by constructing a six (6) inch water line therein.

BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF BEXLEY, STATE OF OHIO:

Section 1. That it is necessary to improve Dawson Avenue from Maryland Avenue to Runl Avenue, by constructing a six (6) inch water main therein, with necessary fire hydrants in accordance with the plans, specifications and estimates prepared by the Engineers of the Village and now on file in the office of the Village Clerk, which plans, specifications and estimates are hereby approved.

Section 2. That the grade of said streets and avenues as improved pursuant to this resolution shall be the natural grade shown by and upon the plans and profiles aforesaid.

Section 3. That the whole cost of said improvement, less two per cent (2%) thereof shall be assessed in proportion to the benefits which may result from said improvement upon the following described lots and lands, to-wit: All of the lots and lands bounding, fronting and abutting upon said proposed improvement, which said lots and lands hereby are determined to be specially benefittes by said improvement and in an amount equal to that part of the cost thereof hereby determined to be assessed thereon.

Section 4. That the assessemtns so to be levied shall be paid in five equal annual installments, with interest on the deferred payments at the same for an shall be borne by the bonds to be hereafter issued in anticipation

Section 6. That bonds of said village shall be issued in anticipation of the collection of said assessments, in an amount sufficient to pay that portion of the cost of said improvement hereinbefore determined to be assessed upon the property fronting and abutting thereon.

shall be paid from the proceeds of bonds of said village issued in the manner provided by law.

Section 8. This resolution shall take effect and be in force from and after the earliest period allowed by law.
