Declaring it necessary to construct sanitary sowers in part of Sanitary Sewer District No. 5.

BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF BEXLEY, STATE OF OHIO:

described of the sanitary sewers provided for in a general plan for a system of sewerage for said Village, which general plan was heretofore adopted by Jouncil and is now on file in the office of the Clerk of said Village; that the portions of the work provided for in said general plan, which it is hereby determined to construct, are as follows, to-wit: The Sanitary sever shown upon the plan of said Sewer District No. 5, as follows:

- (a) An eight (8) inch sewer in Powell Avenue from the alley east of Remington Road to Gould Road.
- (b) An eight (8) inch sewer in the alley east of Roosevelt Avenue from a point 6 feet south of the south line of Lot No. 428 Ardmore Addition to a point 20 feet north of the south line of 456 Ardmore Addition.
- (c) An eight (8) inch sewer in the alley east of Remington Road from a point 20 feet south of the north line of Lot No. 365 Ardmore Addition to the alley south of Broad Street.
- (d) An eight (8) inch sewer in the alley east of Stanwood Road from a point 20 feet south of the north line of Lot No. 366 Ardmore Addition to the alley south of Broad Street.
- (e) An eight (8) inch sewer in the alley south of Broad Street between Remington Road and Stanwood Road.
- (f) An eight (8) inch sewer in the alley south of Broad Street between Stanwood Road and Roosevelt Avenue.

That part of said sewer district so to be improved, being all the lots and lands counding, abutting and fronting upon said improvement.

Be it futther resolved that said sewers, together with the necessary nouse connections for each lot fronting and abutting upon said improvement shall be constructed in accordance with the plans and specifications on file in the office of the Clerk of said Village, and shall be of vitrified pipe

Section 2. Be it further resolved that the entire cost of said improvement, less one-fiftieth (1/50) thereof, shall be assessed in proportion to the benefits which may result from said improvement upon all the lots and lands bounding

and abutting upon said improvement, being the lots hereinabove designated, which said lots and lands are hereby determined to be specially benefited by said improvement; and the cost of said improvement shall include the expense of preliminary and other surveys, the printing and publishing of notices, resolutions and ordinances required, the serving of such notices, the cost of construction, together with interest or bonds issued in anticipation of the collection of deferred assessments and all other necessary expenditures.

Section 5. That the assessments so to be levied shall be paid in five equal annual installments, with interest on the deferred payments at the same rate as shall be borne by the bonds to be hereafter issued in anticipation of the collection of sach assessments.

special assessments and of the issuance of bonds in anticipation of the collection thereof as provided in Section 3914 of the General Gode of Thio. Said notes small not exceed in amount that portion of the estimated cost of the improvement for which said special assessments are to be levied.

Section 5. That bonds of said village shall be issued in anticipation of the collection of said assessments, in an amount sufficient to pay that portion of the cost of said improvement hereinbefore determined to be assessed upon the property fronting and abutting thereon.

from the proceeds of bonds of said Village issued in the manner provided by law.

Section 7. That Resolution No. 552, adopted April 13th, 1926, be, a.d the same is, hereby repealed.
