## RESOLUTION NO. 562.

By Mr. D. W. Kerr.

Declaring it necessary to improve Chelsea Avenue between Main Street and Mound Street, by constructing a sixteen (16) inch water line therein.

BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF BEXLEY, STATE OF OHIO:

Section 1. That it is necessary to improve Chelsea Avenue from Main Street to Mound Street, by constructing a sixteen (16) inch water main therein, with necessary fire hydrants in accordance with the plans, specifications and estimates prepared by the Engineers of the Village and now on file in the office of the Village Clerk, which plans, specifications and estimates are hereby approved.

Section 2. That the grade of said streets and avenues as improved pursuant to this resolution shall be the grade shown by and upon the plans and profiles aforesaid.

Section 3. That the whole tost of said improvement, less 7 % thereof in shall be assessed proportion to the benefits which may result from said improvement upon the following described lots and lands, to-wit: all of the lots and lands bounding, fronting and abutting upon said proposed improvement, which said lots and lands hereby are determined to be specially benefited by said improvement and in an amount equal to that part of the cost thereof hereby determined to be assessed thereon.

Section 4. That the assessments so to be levied shall be paid in five equal annual installments, with interest on the deferred payments at the same rate as shall be borne by the bonds to be hereafter issued in anticipation of the collection of such assessments.

Section 5. That said village may borrow money and issue notes due and payable not later than two years from the date of issue, in anticipation of the levy of said special assessments and of the issuance of bonds in anticipation of the collection thereof as provided in Section 3914 of the General Code of Ohio. Said notes shall not exceed in amount that portion of the estimated cost of the improvement for which said special assessments are to be levied.

Section 6. That bonds of said village shall be issued in anticipation of the collection of said assessments, in an amount sufficient to pay that portion of the cost of said improvement hereinbefore determined to be assessed upon the property fronting and abutting thereon.

Section 7. That the remainder of the cost of said improvement shall be paid from the proceeds of bonds of said Village issued in the manner provided by law.

Section 8. This resolution shall take effect and be in force from and after the earliest period allowed by law.
