## RESOLUTION NO. 575.

Appointing a board to report estimated assessment to pay the cost and expense of certain improvements in the Village of Bexley, Chio.

the construction of water mains as follows, to-with in Main Street between Roosevelt

Avenue and Chelsea Avenue, as provided by Ordinance No. 696, passed March 23, 1926;

also in Walnut Street from Maryland Avenue to Caroline Avenue, as provided in

Ordinance No. 698, passed March 23, 1926, and

WHEREAS, Council has determined to assess the whole cost, less Fourteen percent (14%) thereof, for the construction of water mains in Cassady Road, Maryland Avenue, Allegheny Avenue, Bellwood Avenue, Columbus Avenue, Stanwood Road and Hemlock Street, as provided in Ordinance 697, passed March as, 1926, and

WHEREAS, it has been determined by council to assess the whole cost, less one-fiftieth (1/50) thereof and the cost of intersections, of the improvement of the following described streets in proportion to the benefits which may result from said improvement, to-wit: Stanwood Road between Powell Avenue and Maryland Avenue, as provided by Ordinance No. 699, passed March 23, 1926; Columbia Avenue from Maryland Avenue to Caroline Avenue, as provided by Ordinance No. 700, passed March 23, 1926; Cassady Road from Main Street to Sherwood Road, as provided by Ordinance No. 701, passed March 23, 1926; Chelsea Avenue from Livingston Avenue to Main Street, as provided by Ordinance No. 702, passed March 23, 1926; Cassingham Road from Maryland Avenue to Ruhl Avenue, as provided by Ordinance No. 703, passed March 23, 1926; Drewel Avenue from Maryland Avenue to Caroline Avenue, as provided by Ordinance No. 704, passed March 23, 1926; Ardmore Road from Maryland Avenue to Ruhl Avenue, as provided by Ordinance No. 704, passed March 23, 1926; Ardmore Road from Maryland Avenue to Ruhl Avenue, as provided by Ordinance No. 705, passed March 23, 1926; and Ruhl

Avenue from Cassady Road to the east corporation line, as provided by Ordinance No. 706, passed March 23, 1926,

NOW, THEREFORE:

BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF BEXLEY, STATE OF CHIO:

That C. E. Underwood, W. R. Edmister and R. L. Phelps, three disinterested free holders of the village be, and they are hereby appointed a
board to estimate the assessment of such cost on the lots and lands to be
charged therewith as set forth in the ordinances hereinabove mentioned providing for said improvements in proportion as nearly as may be to the benefits
which may result from the improvements to the several lots or parcels of land
so assessed and to report to this council the said estimated assessment.
