RESOLUTION NO. 585

By Mr. R. J. Wheaton.

Authorizing the Mayor and Clerk to enter into a supplemental contract on behalf of the Village of Bexley, with the Board of County Commissioners of Franklin County, Ohio, relative to the joint construction of certain water mains for the service of said Village of Bexley and territory in said County of Franklin, lying easterly of said Village, being Sewer District Truro No. 1, as provided in contract between said Village and said Board of County commissioners of Franklin County, Ohio, executed November 11, 1925.

BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF BEXLEY, STATE OF OHIO:

Section 1. That the Mayor and Clerk are hereby authorized to enter into a supplemental contract on behalf of the Village of Bexley, with the Board of County Commissioners of Franklin County, Ohio, supplementing the contract heretofore entered into with said Board of County Commissioners on the 11th day of November, 1925, in accordance with the terms and for the purposes therein set forth, a copy of which supplemental contract is as follows:

WHEREAS, The Board of County Commissioners of Franklin County, Ohio, and the Village of Bexley entered into a contract under date of November 11, 1925, under the terms of which said Village was to prepare plans and construct water mains in Maryland Avenue, Mound and Main Streets and Gould Road, and the County of Franklin was to acquire the joint use of said water mains for supplying water to Sewer District Truro No. 1, the several amounts to be paid by the said parties towards the cost of water mains being fully set forth in said contract; and

WHEREAS, The County of Franklin is unable at this time to issue bonds for the payment of its part of said water mains and the said Village has provided funds to pay for its portion of water mains; NOW, THEREFORE,

IT IS AGREED by the said parties that the terms of said contract may be carried out by the immediate construction by the said Village of Bexley of such portion of said water mains as can be constructed within the funds provided by said Village in Maryland Avenue and Mound Street, and that as soon as the County is able to sell its bonds and provide the means for completion of said water mains the proper amount shall be turned over to said Village of Bexley in accordance with the original contract and the said Village shall complete said water mains, and on completion of all such water mains final adjustment shall be made of the total cost in accordance with said original contract, said Village of Bexley being given credit for all amounts expended in the construction of any

part of the water mains described in said original contract.


