

AN ORDINANCE NO. 557.

To levy special assessments for the improvement of Stanwood Road from Broad Street to Maryland Avenue by constructing a six (6) inch water line therein with necessary fire hydrants and water connections.

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BEXLEY, STATE OF OHIO:

Section 1. That the assessment of the cost and expense of improving Stanwood Road from Broad Street to Maryland Avenue, by constructing a six (6) inch water line therein with necessary fire hydrants and water connections, pursuant to and in accordance with an Ordinance No. 592, determining to proceed with said improvement, passed by Council on the 28th day of April, 1925, amounting in the aggregate to Four Thousand, Four Hundred Dollars, (\$4,400.00) as reported to this Council on the 23rd day of November, 1925, by the Board heretofore appointed to estimate said assessments, notice of filing of which assessments has been given as required by law, be and the same is hereby, adopted and confirmed; and that there be, and is hereby, levied and assessed upon the lots and lands bounding and abutting upon said improvement, the several amounts reported as aforesaid, which said assessments, together with the description of said lots and lands are as follows, to-wit:

Notice of Water Main Assessments.
 Notice is hereby given that the estimated assessments of the cost of constructing water mains in the following streets:

(a) Grandon Avenue from Livingston Avenue to Main Street.
 (b) Chelsea Avenue from Livingston Avenue to Mound Street.
 (c) Bratenahl Road from Broad Street to Maryland Avenue.
 (d) Stanwood Road from Broad Street to Maryland Avenue.
 (e) Drexel Avenue, Walnut Street, Dawson Avenue and Cassady Road from Caroline Avenue to Delmar Drive, together with a tie line in Delmar Drive,
 on the lots and lands benefited and to be charged therewith as set forth in resolutions to construct said water lines, has been made and reported to council, and said estimated assessments are now on file in the office of the Clerk of the Council of the Village of Bexley, Ohio, for the inspection and examination by all persons interested therein.

And it is hereby determined and declared by this Council that said lots and lands are each benefited by said improvement in an amount equal to the assessment hereby levied thereon and that said assessments are in proportion to the special benefits.

Section 2. That the total assessment against each lot or parcel of land shall be paid in cash within thirty days from and after the passage of this ordinance, or at the option of the owner, in five annual installments, with interest at the rate of 5% per annum, from October 1st, 1926. All cash payments shall be made to the Treasurer of said Village. All assessments and installments thereof remaining unpaid at the expiration of said thirty days shall be certified by the Clerk to the Auditor of Franklin County, Ohio, as provided by law, to be by him placed upon the tax Duplicate for collection as other taxes are collected.

Section 3. This ordinance shall take effect and be in force from and after the earliest period allowed by law.
