

AN ORDINANCE NO. 684.

Determining to proceed with the construction of sanitary sewers in part of Sanitary Sewer District No. 3.

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BEXLEY, STATE OF OHIO:

Section 1. That it is hereby determined to proceed with the construction of the parts hereinafter described of the sanitary sewers provided for in a general plan for a system of sewerage for said Village, which general plan was adopted by Council on the 11th day of June, 1918, and is now on file in the office of the Clerk of said Village; that the portions of the work provided for in said general plan which it is hereby determined to construct are as follows, to-wit: The sanitary sewers shown upon the plan of said Sewer District No. 3 as follows:

An eight (8) inch sewer in Maryland Avenue from the west line of Walnut Avenue to the west line of Drexel Avenue, and an eight (8) inch sewer in Drexel Avenue from Maryland Avenue to a point thirty-three (33) feet south of the south line of Caroline Avenue.

That part of said sewer district so to be improved, being all the lots and lands bounding, abutting and fronting upon said improvement.

Section 2. Said sewers, together with the necessary house connections for each lots fronting and abutting upon said improvement shall be constructed pursuant to Resolution No. 527, adopted January 26th, 1926, and in accordance with the plans and specifications heretofore prepared by the engineer of said Village and now on file in the office of the Clerk of said Village and said sewers shall be of vitrified pipe.

Section 3. That the entire cost of said improvement, less one-fiftieth (1/50) thereof shall be assessed in proportion to the benefits which may result from said improvement upon all the lots and lands bounding and abutting upon said improvement, which said lots and lands are hereby determined to be specially benefited by said improvement and the cost of said improvement shall include the expense of preliminary and other surveys, the printing and publishing of notices, resolutions and ordinances required, the serving of such notices, the cost of construction, together with interest on notes or bonds issued in anticipation of the collection of deferred assessments and all other necessary expenditures.

Section 4. That the assessments so levied shall be paid in five

equal annual installments, with interest on deferred payments at the same rate as shall be borne by the bonds issued in anticipation of the collection of said special assessments.

Section 5. That bonds shall be issued in anticipation of the collection of said assessments by installments, in an amount equal thereto.

Section 6. That the clerk be, and hereby is authorized to advertise for bids for the construction of said improvement, as provided by law.

Section 7. This ordinance shall take effect and be in force from and after the earliest period allowed by law.




