

## AN ORDINANCE NO. 890.

To levy special assessments for the construction of sidewalks on the south side of Main Street between Roosevelt Avenue and Remington Road (formerly Rocne Avenue).

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BEXLEY, STATE OF OHIO:

Section 1. That the assessment of the cost and expense of constructing sidewalks on the south side of Main Street between Roosevelt Avenue and Remington Road (formerly Rocne Avenue), pursuant to a resolution No. 482, adopted on the 23rd day of June, 1925, ordering said improvement to be made, amounting in the aggregate to Six Hundred Dollars and Twenty-eight Cents (\$600.28), as reported to Council by the Village Engineers on January 9th, 1926, notice of the filing of which report and the assessment has been given as required by law, be, and the same is hereby, approved, adopted and confirmed and that there be, and is hereby, levied and assessed upon the lots and lands bounding and abutting upon said improvement, the several amounts reported as aforesaid, which assessments, together with the description of said lots and lands, are as follows, to-wit:

Section 2. That the total assessment against each lot or parcel of land shall be payable to the Treasurer of the Village in cash within ten days from the time same is reported to the owner thereof as hereinafter provided, the same to be certified by the Clerk, together with a penalty of 5% thereon, to the County Auditor who shall place the same on the Treasurer's Duplicate and collect the same, together with penalty, in the same manner as other taxes are collected.

Section 3. The Clerk is hereby directed to cause written notice of said assessments to be given to the owners of each lot or parcel of land so

hereinabove assessed and of the date of payment thereof.

Section 4. This ordinance shall take effect and be in force from and after the earliest period allowed by law.
