

AN ORDINANCE NO. 724.

Authorizing the borrowing of money and the issuing of notes of the Village of Bexley, Ohio, in anticipation of the levy of special assessments for the improvement of certain streets and avenues in the Village of Bexley, by constructing water lines therein.

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BEXLEY, STATE OF OHIO:

Section 1. That the Village of Bexley be, and hereby is, authorized to borrow money in the sum of Twenty-one Thousand, One Hundred Dollars (\$21,100.00) and to issue the notes of said Village therefor in anticipation of the levy of special assessments and the issuing of bonds in anticipation of the collection of said assessments, as provided by Section 3914 General Code, to pay the costs heretofore determined to be specially assessed for the improvement of the following streets and avenues in the Village of Bexley, by constructing water lines, as follows, to-wit:

Cassady Road from Maryland Avenue to Caroline Avenue, by constructing a twelve (12) inch water main therein.

Maryland Avenue (in Bellwood Addition) from Cassady Road to Hemlock Street, by constructing a six (6) inch water main therein.

Allegheny Avenue from Cassady Road to Hemlock Street, by constructing a six (6) inch water main therein.

Columbus Avenue from Cassady Road to the east line of Bellwood Addition, by constructing a six (6) inch water main therein.

Stanwood Road from Maryland Avenue to the north line of Beacon Hill Addition, by constructing a six (6) inch water main therein.

Hemlock Street from the north line of Beacon Hill Addition to Maryland Avenue in Bellwood Addition, by constructing a six (6) inch tie line therein, connecting the above mentioned mains, said lines hereinabove provided being one improvement; also constructing the necessary fire hydrants; in accordance with the plans, specifications and estimates are hereby approved, provided by Resolution No. 526, declaring the necessity therefor, adopted January 26th, 1926, and in pursuance of an Ordinance No. 697, determining to proceed with said improvement, passed March 23rd, 1926.


Section 2. That said notes shall be in denominations of One Thousand Dollars (\$1,000.00) each, or any multiple thereof, or such smaller denomination as may be necessary, shall be signed by the Mayor, attested by the Clerk, be

sealed with the seal of the Village, bear date as issued and shall be due and payable not later than two years from date of issue. Said notes shall be numbered consecutively beginning with number one (1) and shall bear interest at the lowest rate obtainable, but not in excess of 6% per annum, payable semi-annually. The proceeds of the bonds issued in anticipation of the collection of the assessments, and all of the assessments collected for said improvement, shall be applied to the payment of said notes and interest thereon until both are fully paid, and thereafter said assessments shall be applied to the payment of said bonds and interest thereon.

Section 3. That the Finance Committee of this Council shall cause said notes to be properly prepared, executed and sold according to law to the person, persons, company or corporation offering the lowest rate of interest, and shall deposit the proceeds in the Village Treasury to the credit of Sundry Sewer Improvement Fund.


Section 4. This ordinance shall take effect and be in force from and after the earliest period allowed by law.
