

AN ORDINANCE NO. 728.

Determining to proceed with the construction of sanitary sewer in part of Sanitary Sewer District No. 5.

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BENLEY, STATE OF OHIO:

Section 1. That it is hereby determined to proceed with the construction of a part hereinafter described of sanitary sewers provided for in a general plan for a system of sewerage for said Village, which general plan was heretofore adopted by Council and is now on file in the office of the Clerk of said Village; that the portions of the work provided for in said general plan which it is hereby determined to construct are as follows, to-wit: The sanitary sewers shown upon the plan of said Sewer District No. 5 as follows:

(a) An eight (8) inch sewer in Maryland Avenue from a point 119 feet east of the east line of Stanwood Road to a point 35.5 feet west of the east line of Gould Road.

(b) An eight (8) inch sewer in an easement along the east line of Beacon Hill Addition from Maryland Avenue to the first alley north of Ruhl Avenue.

(c) An eight (8) inch sewer in Ruhl Avenue from the first alley east of Cassingham Road to the East line of Beacon Hill Addition.

(d) An eight (8) inch sewer in the alley east of Cassingham Road from Maryland Avenue to Ruhl Avenue.

(e) An eight (8) inch sewer in the alley east of Remington Road from Maryland Avenue to Ruhl Avenue.

(f) An eight (8) inch sewer in the alley north of Ruhl Avenue from Cassingham Road to the East line of Bellwood Addition.

(g) An eight (8) inch sewer in Hemlock Street from the Alley north of Ruhl Avenue to Maryland Avenue (Bellwood Addition).

(h) An eight (8) inch sewer in the alley north of Columbus Avenue from Spruce Street to 20 feet west of the east line of Bellwood Addition.

(i) An eight (8) inch sewer in the alley north of Bellwood Avenue from Spruce Street to Hemlock Street.

(j) An eight (8) inch sewer in the alley north of Allegheny Avenue from Spruce Street to Hemlock Street.

That part of said sewer district so to be improved, being all the lots and lands bounding, abutting and fronting upon said improvement.

Section 2. That said sewers, together with the necessary house connections for each lot fronting and abutting upon said improvement shall be constructed pursuant to Resolution No. 548, adopted March 23rd. 1926, and in accordance with the plans and specifications heretofore prepared by the engineer of said Village and now on file in the office of the Clerk of said Village and said sewers shall be of vitrified pipe.

Section 3. That the entire cost of said improvement, less one-

fiftieth (1/50) thereof, shall be assessed in proportion to the benefits which may result from said improvement upon all the lots and lands bounding and abutting upon said improvement, which said lots and lands are hereby determined to be specially benefited by said improvement and the cost of said improvement shall include the expense of preliminary and other surveys, the printing and publishing of notices, resolutions and ordinances required, the serving of such notices, the cost of construction, together with interest on notes or bonds issued in anticipation of the collection of deferred assessments and all other necessary expenditures.


Section 4. That the assessments so levied shall be paid in five equal annual installments with interest on deferred payments at the same rate as shall be borne by the bonds to be issued in anticipation of the collection thereof; provided that the owner of any property assessed, may at his option, pay such assessments in cash within thirty days after the passage of the assessment ordinance, upon due notice being given.

Section 5. That bonds shall be issued in anticipation of the collection of said assessments by installments, in an amount equal thereto.

Section 6. That the Clerk be, and hereby is, authorized to advertise for bids for the construction of said improvement, as provided by law.

Section 7. This ordinance shall take effect and be in force from and after the earliest period allowed by law.




