AN ORDINANCE NO. 742.

By Mr. Manly.

To regulate traffic at the junction of Drexel Avenue and Main Street.

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BELLEY, STATE OF OHIO:

Section 1. That no vehicle or vehicles shall stand on, or be parked on, whether accompanied or unaccompanied by an operator, the following part or parts of Drexel avenue or Main Street in the Village of Bexley, to-wit: On that part of Drexel avenue from the north curb line of Main Street, produced, to a line parallel with said north line of Main Street and 38 feet north thereof; on that part of Main Street between the north curb line thereof and the center line of said street, from a point 90 feet west of the west curb line of Drexel Avenue, porduced, to a point 22 feet east of theeast curb line of Drexel Avenue, produced; or on that part of Main Street between the south curb line of Main Street and the center line of Main Street beginning at a point 114 feet west of the center line of Drexel Avenue, produced southerly, to a point 50 feet east of said center line of Drexel Avenue, produced southerly.

The Marshal shall erect or cause to be erected proper signs, and shall mark or cause to be marked ald streets, defining the above described portions of said Main Street and Drexel Avenue.

Section 2. That all east bound street cars shall stop at the lot line on Main Street for taking on and discharging passengers, before entering upon Drexel Avenue, and all south or west bound street cars on Drexel Avenue shall come to a stop before turning on to Main Street, but shall not discharge or take on passengers until after turning onto Main Street.

Section 3. As provided in Ordinance No. 450, and subject to the regulations in said Ordinance provided, safety zones are hereby established in Lain Street of the width of five feet, measured from the south rail of the street car tract toward the south curb line, and from the north rail of the street car tract toward the horth curb, respectively, and extending from the lot line on the west side of Drewel Avenue, extended southwardly, to a point sixth feet west therefrom. The village Marshall shall mark said safety Lones with both standards and lines, as provided in Section 14 (d) of said Ordinance No. 450.

Section 4. Any person violating any of the provisions of this Ordinance shall, upon conviction thereof, be fined not less than five dollars (\$5.00) and not more than twenty-five dollars (\$25.00).

Section 5. That Ordinance No. 626, passed August 11th, 1925, be and the same is hereby repealed.

Section 6. That this ordinance shall take effect and be in force from , and after the earlest period allowed by law.
