and it is hereby determined and declared by this Council that said lots and lands are each benefited by said improvement in anamount equal to the assessment hereby levied thereon and that said assessments are in proportion

to the special benefits.

Section 2. That the total assessment against each lot or parcel of land shall be paid in cash within thirty days from and after the passage of this ordinance, or at the option of the owner, in five annual installments, with interest at the rate of 5% per annum, from October 1st, 1926. All cash payments shall be made to the Treasurer of said Village. All assessments and installments thereof remaining unpaid at the expiration of said thirty days shall be certified by the Clerk to the Auditor of Franklin County, Ohio, as provided by law to be by him placed upon the tax Miplicate for collection as other taxes are collected.

Section 3. This ordinance shall take effect and be in force from and after the earliest period allowed by law.
