

AN ORDINANCE NO. 790.

To levy special assessments for the construction of sanitary sewers in part of Sanitary Sewer District No. ~~4~~.

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BEAULEY, STATE OF OHIO:

Section 1. That the assessment of the cost and expense of constructing sanitary sewers in part of Sanitary Sewer District No. ~~4~~ as follows, to-wit:

(a) An eight (8) inch sewer in Livingston Avenue from Euclaire Avenue to Cassingham Road.

(b) An eight (8) inch sewer in Cassingham Road from Livingston Avenue to Charles Street.

(c) An eight (8) inch sewer in the alley between Cassingham Road and Montrose Avenue from the alley north of Livingston Avenue to Charles Street,

(d) An eight (8) inch sewer in the alley north of Livingston Avenue from Cassingham Road to the alley east of Montrose Avenue,

pursuant to and in accordance with an Ordinance No. 760, determining to proceed with said improvement, passed on the 13th day of July, 1926, amounting in the aggregate to Five Thousand , Two Hundred Dollars and Sixteen Cents (\$5,200.16) as reported to this Council on the 15th day of October, 1926, by the Board heretofore appointed to estimate said assessments, notice of filing of which assessments has been given as required by law, be, and the same is hereby, adopted and confirmed; and that there be, and is hereby, levied and assessed upon the lots and lands bounding and abutting upon said improvement, together with the description of said lots and lands are as follows, to-wit:

And it is hereby determined and declared by this Council that said lots and lands are each benefited by said improvement in an amount equal to the assessment hereby levied thereon, and that said assessments are in proportion to the special benefits.

Section 2. That the Total assessment against each lot or parcel of land shall be paid in cash within thirty days from and after the passage of this Ordinance, or at the option of the owner, in five annual installments, with interest at the rate of 5% per annum, from April 1st, 1927. All cash payments shall be made to the Treasurer of said Village. All assessments and installments thereof remaining unpaid at the expiration of said thirty days shall be certified by the clerk to the Auditor of Franklin County, Ohio, as provided by law to be by him placed upon the tax duplicate for collection as other taxes are collected.

Section 3. This ordinance shall take effect and be in force from and after the earliest period allowed by law.
