

RESOLUTION No. 613.

By Mr. Manly.

Declaring it necessary to improve Bryden Road from Cassady Road to Remington Road.

BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF BEXLEY, STATE OF OHIO:

Section 1. That it is necessary to improve Bryden Road between Cassady Road and Remington Road in said Village by grading, curbing and paving the roadway thereof with brick, asphalt, concrete or someother form of permanent improvement, and constructing the necessary sewers or drains to furnish proper drainage for such improvement and erecting street signs, in accordance with the plans, specifications, estimates and profiles heretofore filed with this council, which are hereby approved.

Section 2. That the grade of said Bryden Road as improved shall be the grade shoen by and upon the plans and profiles aforesaid and the grade of the curbs shall be as follows, to-wit:

NORTH CURB-

Beginning at the west line of Cassady Road Station 0+00 and elevation 103.78; thence easterly with a 0.30% ascending grade to the center line of Cassady Road, Station 0+40 and elevation 103.90; thence easterly with a 0.57% ascending grade to the west curb line of Remington Road, Station 12+65.6 and elevation 110.89; thence easterly level to the east line of Remington Road, Station 12+90.6 and elevation 110.89.

SOUTH CURB-

The elevation of the south curb to be the same as that of the north curb.

The above elevations refer to Village Datum.

Section 3. That the whole cost of said improvement, less one-fiftieth (1/50) thereof and the cost of intersections shall be specially assessed in proportion to the benefits which may result from said improvement upon the following described lots and lands, to-wit: All of the lots and lands bounding, fronting and abutting upon said improvement, which lots and lands hereby are determined to be specially benefited by said improvement and in the amount equal to that part of the cost thereof hereby determined to be assessed thereon.

Section 4. That the special assessments so to be levied shall be paid in not less than nine or more than ten equal annual installments with interest on the deferred payments at the same rate as shall be borne by the bonds to be hereafter issued in anticipation of the collection of such assessments.

Section 5. That said Village may borrow money and issue notes due and payable not later than two years from date of issue, in anticipation of the levy of said assessments and of the issuance of bonds in anticipation of the collection of said special assessments as provided in Section 3914 of the General Code of Ohio, said notes shall not exceed in amount that portion of the estimated cost of the improvement for which said assessments are to be levied.

Section 6. That bonds of said village shall be issued, in anticipation of the collection of said assessments, in an amount sufficient to pay that portion of the estimated cost of said improvement hereinbefore determined to be assessed upon the property fronting and abutting thereon.

Section 7. ~~This resolution shall take effect and be in force from and after the earliest period allowed by law.~~ That the Village's portion of the cost of said improvement shall be paid from the proceeds of bonds, issued by said village in the manner provided by law.

Section 8. This resolution shall take effect and be in force from and after the earliest period allowed by law.
