

AN ORDINANCE NO. 898.

To levy special assessments for the improvement of Grandon Avenue from Livingston Avenue to Main Street.

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BEXLEY, STATE OF OHIO:

Section 1. That the assessment of the cost and expense of improving Grandon Avenue from Livingston Avenue to Main Street, by grading, curbing and paving the roadway thereof with asphalt, constructing necessary sewers or drains and erecting street signs, pursuant to and in accordance with Ordinance No. 827, determining to proceed with said improvement, passed by Council on the 13th day of March, 1927, in the aggregate amount of thirty-four thousand, seven hundred dollars (\$34,700.00) as reported to this Council on the 22nd day of November, 1927, by the Board heretofore appointed to estimate said assessments, notice of filing of which assessments has been given as required by law be, and the same is hereby, adopted and confirmed; and that there be, and is hereby levied and assessed upon the lots and lands bounding and abutting upon said improvement, the several amounts reported as aforesaid, which said assessments, together with the description of said lots and lands, are as follows, to-wit:
