AN ORDINANCE NO. 907.

To provide for the issue of bonds in anticipation of the levy and of the collection of special assessments for the improvement of Grandon Avenue from Livingston Avenue to Main Street by grading, curbing and paving the roadway thereof with asphalt, constructing sewers or drains necessary to furnish proper drainage and erecting street signs.

WHEREAS, the Village Glerk, pursuant to the provisions of Section 2295-7 of the General Code of Onio, has certified to this Council that the estimated life of the improvement porposed to be constructed from the proceeds of the bonds hereinafter mentioned, is ten years, and has further certified the maximum maturity of such bonds calculated in accordance with the provisions of Sections 2295-9 and 2295-9 or General Code, to be ten years, and

the payment of said bonds and a tax to provide for any deficience to the payment of said assessments will first appear upon the duplicate for the tax year 1928, and that the final tax settlement with the County Treasurer next following the inclusion of such tax in the annual budget by the County Auditor as provided by law, will be obtained not earlier than the first day of beptember, 1929, and will require \$1500.00 for interest until such assessment and taxes are collected and available;

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BEXLEY. STATE OF ONIOS

Section 1. That wonds of said Village shall be issued in the aggregate amount of \$54,700.00 for the purpose of raising money in anticipation of the levy and of the collection of special assessments to pay that portion of the cost and expense heretof is determined to be assessed for the improvement of Grandon Avenue from Living of a Avenue to Main Street by grading, curbing and paving the roadway the with asphalt, constructing severs or drains necessary to furnish proper drainage and erecting street signs, in pursuance of Ordinance No. 827 determining to proceed with said improvement, passed March 15th, 1927. and to provide a fund for the payment of not to exceed one year's int on said bonds.

Improvement bonds," and serially numbered from one (1) to thirty -six (36) both inclusive. They shall be of the denomination of \$1000.00 each, except Nos. 4 and 8 shall be for \$350.00 each, bearing date of March 1st, 1928, and shall bear interest at the rate of four and 38/100 (4.38%) per tent per annum, payable semi-annually on the first day of April and Cotober each year, for which interest coupons bearing the fac simile signature of the Clerk of said Village shall be attached to and made part thereof. Said bonds shall fall dre and be payable in the order of their serial number as follows, to-wit:

Nos. 1, 2, 3 and 4 shall be due October 1stm 1929, and four bonds on the 1st day of October each year to and including October 1st, 1937.

Section 3. Said bords shall be prepared by the Village Solicitor, signed by the Mayor and Village Clerk, and sealed with the seal of the Village of Bexley; they shall express upon their face the purpose for which they are issued, and the fact that they are issued pursuant to law, and this ordinal e; they shall be payable, both principal and interest, at the office of the Treasurer of the Village; and shall be issued and sold under the direction of the finance committee of this council.

Section 4. That upon the sale of said bonds, any premium and accrued interest realized therefrom shall be paid to the sinking fund trustees to be applied to the mayment of the principal and interest of said bonds. The par value realized from the sale of said bonds shall be deposited in the village treasury to the credit of the "Grandon Avenue Improvement Fund" and shall be disbursed from said fund on proper vouchers in payment of that part of the cost of the improvement aforescid, heretofore determined to be especially assessed, and to the payment of motes heretofore issued for that purpose, for which purpose said money is hereby appropriated.

Section 6. That all installments of said assessments and all portions thereof, together with interest thereon, shall be applied to the payment of said assessments and all payment of said assessments and all portions thereof, together with interest thereon, shall be applied to the payment of said assessments and all

Section 6. That said bonds shall be full general obligations of said village, and for the payment of the principal and interest of the same, the full faith, credit and revenues of said village shall be and hereby are pledged.

Section 7. That for the purpose of providing the necessary funds to pay the interest and the principal of said bonds promptly when and as they mature, and to create and maintain a sinking fund sufficient to discharge said bonds at maturity, there shall be and hereby is levied on all the taxable property of said village in addition to all other taxes, a direct tax annually until the maximum date of maturity of said bonds in an amount sufficient to provide for payment of said bonds and interest as they fall due. That said taxes shall be and hereby are ordered computed, certified, levied and extended upon the tax duplicate and collected by the same officer, in the same manner and at the same time that taxes for general purposes for each year are certified, extended and collected. That all funds derived from the tax levies hereby made, shall be placed in a separate and distinct fund, which, together with all interest collected on the same, is, irrevocably pleaged for the payment of the interest and principal of said bonds when and as the same fall dage.

Section 8. This ordinance shall take effect and be in force from and after the earliest period allowed by law.
