BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BEXLEY, STATE OF OHIO:

Section 1. That the assessment of the cost and expense of improving Walnut Street from Maryland Avenue to Delmar Drive, by grading, curbing and paving the roadway thereof with asphalt, constructing the necessary sewers or drains and erecting street signs, pursuant to and in accordance with Ordinance No. 825, determining to proceed with said improvement, passed by Council on the 15th day of March, 1927, in the aggregate amount of Twenty-two Thousand, Four Hundred Dollars (\$22,400.00) as reported to this Council on the 25rd day of December, 1927, by the Board heretofore appointed to estimate said assessments, notice of filing of which assessments has been given as required by law be, and the same is hereby, edopted and confirmed; and there there be, and is hereby, levied and assessed upon the lots and lands bounding and abutting upon said improvement, the several amounts reported as aforesaid, which said assessments, together with the description of said lots and lands, are as follows, to-wit:
