To levy special assessments for constructing a storm sewer in Clifton Avenue between Alum Creek and a point approximately 300 feet west of Parkview Avenue.

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BEXLEY, STATE OF OHIO:

Expense of constructing a storm sever in Clifton Avenue between Alum Creek and a point approximately 360 feet west of Parkview Avenue, pursuant to and in accordance with Ordinance No. 854, determining to proceed with said improvement, passed by Council on the 26th day of April, 1927, in the aggregate amount of Nine Thousand Thirty-two Dollars (\$9,032.00) as reported to this Council on the 14th day of December, 1927, by the Board heretofore appointed to estimate said assessments, notice of filing of which assessments has been given as required by law be, and the same is hereby, adopted and confirmed; and that there be, and is hereby, levied and assessed upon the lots and lands bounding and abutting upon said improvement, the several amounts reported as aforesaid, which said assessments, together with the description of said lots and lands, are as follows, to-wit:

All assessments and installments thereof remaining unpaid at the expiration of said thirty days shall be certified by the Clerk to the Auditor of Franklin County, Ohio, as provided by law to be by him placed upon the tax duplicate for collection as other taxes are collected.
