AN ORDINATCE NO. 943.

Authorizing the borrowing of meney and the issuing of notes of the Village of Bexley, Ohio, in anticipation of the levy of special assessments for the improvement of Remington Road from Powell Avenue to Elm Avenue.

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BEXLEY, STATE OF OHIO:

Section 1. That the Village of Bexley, Ohio, be and hereby is, authorized to borrow money in the sum of Four Thousand, Six Hundred Dollars (\$4,600.00) and to issue the notes of said Village therefor in anticipation of the levy of special assessments and of the issue of bonds in anticipation of the collection of said assessments as provided by Section 2293-24 of the General Code of Ohio, to pay that part of the cost heretofore determined to be specially assessed for the improvement of Remington Road between Powell Avenue and Elm Avenue in said Village, by grading, curbing and paving the roadway thereof with brick, asphalt, concrete or some other form of permanent improvement, and constructing the necessary sewers or drains to furnish proper drainage for such improvement from the south curb line of BELm Avenue extended, to a point approximately one hundred and seventy-four (174) feet south of the south line of Powell Avenue; by widening the paved portion of said street to thirty (30) feet between a point approximately one hundred and seventy-four (174) feet south of the south line of Powell Avenue to the north line of Powell Avenue by setting back the curb and gutter three (3) feet on each side and paving said widened portion of said roadway to conform to the existing improvement and making the necessary changes in drains to provide proper drainage for said improvement; also by constructing sidewalks on both sides of said street from the south curb line of Elm Avenue extended, to the south line of Powell Avenue, and erecting street signs, as provided by Resolution No. 709, declaring the necessity therefor, adopted February 28th, 1928, and in pursuance of an Ordinanue No. . . determining to proceed with said improvement, passed April 10th, 1928.

Section 2. That said notes shall be in the denominations of One Thousand Dollars (\$1,000.00) each, or any multiple thereof, or such smaller denomination as may be necessary, shall be signed by the Mayor, attested by the Clark, be sealed with the seal of the Village, bear date as issued and shall be due and payable not later than wwo years from date of issue. Said notes shall be numbered consecutively beginning with number one (1), and shall bear interest at the rate of 5 % per annum, payable semi-annually. The proceeds of the bonds issued in anticipation of the collection of the assessments, and all of the assessments collected for said improvement, shall be applied to the payment of said notes and interest thereon until both are fully paid, and thereafter said assessments shall be applied to the payment of said bonds and the interest thereon. Said notes shall be the full general obligations of the Village and the full faith and revenue of the Village are hereby pledged for the payment of the same and for the levy of assessments for said improvement and for the issue of bonds in anticipation of the collection of such assessments. In the event that said assessments are not levied or bonds are not issued to provide a fund for the payment of such notes at maturity, a general tax shall be levied against all interest thereon.

Section 3. That the Finance Committee of this Council shall cause said notes to be properly prepared, executed and sold according to law; the same shall First be offered to the trustees of the Sinking Fund of the Village at par and accrued interest and any notes not purchased by said trustees shall be sold at private sale to the person, persons, company or corporations offering the best price therefor, but shall not be sold for less than par and accrued interest and shall deposit the proceeds in the Village Treasury to the proceeds of "Remington Road Improvement Fund".

Section 4. This ordinance shall take effect and be in force from and after the earliest period allowed by law.
