## ORDINANCE NO. 975.

By Mr. Samuel Betz,

To fix the salaries, compensation and bonds of Village officials and employees and to repeal existing ordinances inconsistent therewith.

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BEXLEY, STATE OF OHIO:

Section 1. That the salary of the Mayor of the Village shall be Twelve Hundred Dollars (\$1200.00) per annum and he shall give bond in the sum of Five Hundred Dollars (\$500.00). All fees and costs collected in the Mayor's Court in criminal cases shall be paid into the Village Treasury.

Section 2. That the salary of the Clerk shall be One Thousand Dollars (\$1,000.00) per annum and the compensation of a deputy Clerk shall be One Hundred Dollars (\$100.00) per month and each shall give bond in the sum of Five Hundred Dollars (\$500.00). The salary of one deputy clerk to serve notices shall be Five Dollars (\$5.00) per day for each day of service.

Section 3. That the salary of the Treasurer shall be Three Hundred Dollars (\$300.00) per annum, and he shall give bond in the sun of Twenty-five Hundred Dollars (\$2500.00).

Section 4. That the salary of the Solicitor shall be Eighteen Hundred Dollars (\$1800.00) per annum for all services rendered as attorney and counsel for the village and the officials thereof in their official capacity, provided however, said Solicitor shall not be required to render any service to said Village or officials in any litigated matters for the salary and compensation aforesaid, but, in case his services should be required by said Village or officials in any case or cases wherein the Village is involved or about to be involved in litigation, he shall receive for such services such sum or sums as may be agreed upon by such Solicitor and the Council. The Solicitor shall give bond in the sum of Five Hundred Dollars (\$500.00).

Section 5. That the salary of the Building Inspector of said Village shall be Twenty-four Hundred Dollars (\$2400.00) per annum, and he shall give bond in the sum of Five Hundred (\$500.00) Dollars.

Section 6. The salary of the Marshal shall be in the sum of Fifty Dollars (\$50.00) per annum, in addition to such fees as are allowed by law, and he shall give bond in the sum of Five Hundred

Dollars (\$500.00).

Section 7. The salary of the chief of Deputy Marshal shall be not to exceed Two Hundred Dollars (\$200.00) per month and the salary of the other deputy Marshals, while acting as such, shall be not to exceed One Hundred and Sixty-five Dollars (\$165.00) per month, and each shall give bond in the sum of Five Hundred Dollars (\$500.00).

Section 8. The salary of the Street Commissioner shall be Twenty-eight Hundred and Eighty Dollars (\$2880.09) per annum; that the compensation of One Assistant Street Commissioner shall be at the rate of not to exceed Eighteen Hundred Dollars (\$1800.00) per annum while continuously employed; the compensation of common laborers shall be not to exceed sixty-five cents (65¢) per hour, excepting laborers employed in garbage collections shall be paid sixty-two and one-half cents (62½¢) per hour; the compensation for each team and driver employed by said Street Commissioner shall be not to exceed One Dollar (\$1.00) per hour; of each team, driver and mower, not to exceed One Dollar and Twenty-five cents (\$1.25) per hour; mechanic's, not to exceed One Dollar and Twenty-five Cents (\$1.25) per hour, with time and one-half for over time and double time for Sunday labor, said Street Commissioner shall give bond in the sum of Five Hundred Dollars (\$500.00).

Section 9. There shall be a clerk of Trustees of the Sinking Fund and his calary shall be Nine Hundred Dollars (\$900.00) per annum. He shall give bon in the sum of Ten Thousand Dollars (\$10,000.00) as provided by 10.

Section 10. The constant of each member of the Board of Trustees of Public Affairs and his salary shall be Twenty-five Hundred and Eighty Dollars (\$2.00) for each hall be Twe Dollars (\$2.00) for each and every meeting whether the same be a regular, adjourned or calle and provided further that no member of the loard whall receive any compensation whatever for any meetings of the Board which he does not attend, and each member shall give bond in the sum of \$1,000.00, the Clerk of the Board of Trustees of Public Affairs shall devote his entire time to the business of public affairs and his salary shall be Twenty-five Hundred and Eighty Dollars (\$2580.00) per annum. He shall give

bond in the sum of Three Thousand Dollars (\$3,000.00).

Section 11. The compensation of each member of the Village Council shall be Two Dollars (\$2.00) for each and every meeting of the Council, whether the same be a regular, adjourned or called meeting, provided said meetings shall not exceed twenty-four in any year, and provided further that no member of Council shall receive any compensation whatever for any meetings of the Council which he does not attend, and answer to his name on roll call, as shown by the minutes of the Clerk.

Section 12. That the salaries and compensation of each of the above named officials and members of the Council of the Village shall be paid quarterly, except the salaries of the Clerk, deputy Clerk, Clerk of the Board of Trustees of Public Affairs, Clerk of the Trustees of the Sinking Fund, The Building Inspector, Street Commissioner, Assistant to the Street Commissioner, the Deputy Marshal, and Solicitor which shall be paid monthly, out of the Village Treasury after the same has become due, and the Clerk and Treasurer are hereby authorized and directed to pay said salaries and compensation, when due as herein provided without other action of the Council thereon.

Section 13. That Ordinance No. 885, heretofore passed on November 29,1,1927,4, and all other ordinances inconsistent with the provisions hereof be, and the same are hereby repealed.

Section 14. That this ordinance shall take effect and be in force from and after the earliest period allowed by law.
