AN ORDINANCE NO. 1013.

Determining to proceed with the construction and installation of a system of lighting for certain streets and avenues in the Village of Bexley, Ohio.

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BEXLEY, STATE OF OHIO:

Section 1. That it is hereby determined to proceed with the construction and installation of a system for lighting the following streets and avenues in the Village of Bexley, to-wit:

- (a) Columbia Avenue from Maryland Avenue to Ruhl Avenue.
- (b) Mound Street from College Avenue to Euclaire Avenue, by laying under ground cables, erecting iron light standards, installing lamps, conduits and other necessary equipment, in pursuance of a Resolution No. 775, declaring it necessary to provide for lighting certain streets in the Village of Bexley, Chio, adopted on the 25rd day of April, 1929, and in accordance with the plans, specifications, estimates and profiles for said system of lighting now on file in the office of the Village Clerk which are hereby approved.

Section 2. That all claims for damages resulting from the construction and installation of said lighting system shall be judicially inquired into after the completion thereof, and the Solicitor be and hereby is authorized and directed to institute proceedings in a court of Competent Jurisdiction to inquire into such claims.

installing said system for lighting said streets and evenues, except one-fiftieth (1/50) thereof, and the cost of intersections, shall be specially assessed in proportion to the benefits which may result from said improvements on all the lots and lands bounding, fronting, and abutting upon said proposed improvements between the points aforesaid, which said lots and lands are hereby determined to be specially benefited by said improvement, and in an amount equal to that part of the cost thereof hereby determined to be assessed thereon.

Section 4. That the special assessments so to be levied shall be paid in five substantially equal annual installments with interest on the deferred payments at the same rate as shall be borne by the bonds to be hereafter issued in anticipation of the collection of said special assessments.

Section 5. That money shall be borrowed and the notes of said Village issued therefor in an amount not to exceed the estimated cost of said improvement, due and payable not later than two years from the date of issue, in anticipation of the levy of said special assessments, and of the issuance of bonds in anticipation of the collection of said special assessments.

Section 6. That bonds of said village shall be issued in anticipation of the collection of said special assessments, in an amount sufficient to pay that portion of the estimated cost of said improvement for which said assessments are levied.

Section 7. That the remainder of the cost of said improvement shall be paid from the proceeds of bonds of said village issued in the manner provided by law.

Section 8. That the Clerk of said Village be and hereby is authorized and directed to advertise for bids for the construction and installation of said system of lighting in the manner provided by law.

Section 9. This ordinance shall take effect and be in force from and after the earliest period allowed by law.
