(h) Elm Av que from Cassady Road to Remington Road.

(i) Haven and rive South from Euclaire Avenue to Cassing-

(') Montrose Avenue from Main Street to Livingston Avenue.
(1) Remington Road from Main Street to first alley south

of Astor Avenue.

(m) Vernon Road from Main Street to first alley south of Astor Avenue.

(n) Roosevelt Avenue from Main Street to first alley south

of Astor Agenue.
(6) Chelsea Avenue from Main Street to Charles Street.

has been completed by the Globe Indemnity Company, the surety upon the bond of R. Lee McComb, the contractor, said contractor having defaulted upon his said contract and abandoned the same, and the acceptance of said improvement has been recommended by the engineers of the Village, and the final estimate of the cost thereof has been filed by said engineers, showing a balance due at this time upon said contract in the sum of \$2,494.51, from which sum there is deductable the amount of \$475.11, representing sums which the Village was authorized to expend upon said improvement by said contractor and his said surety, leaving a balance due and owing at this time in the sum of \$2,019.40, and

Section 1. That said improvement for the installation of said system of lighting be and the same is hereby accepted and said final estimate is hereby ordered paid. Said sum so remaining in the hands of the Village being insufficient to pay said liens in full the

Clerk is hereby authorized to apply said sum pro rata upon said liens so filed against said fund at such time as said liens may be determined to be proper and valid liens against the same, or when and as authorized by the Surety upon said contract bond.
