

ORDINANCE NO. 984.

To correct special assessments heretofore levied and assessed against premises of the Forrest Realty Company in the Village of Bexley, Ohio, and

Whereas, by Ordinance No. 500 entitled "An Ordinance No. 300 to levy special assessments for the construction of the main sanitary sewers in Sewer Districts Nos. 3 and 4" duly passed by the Council of the Village of Bexley on the 12th. day of September, 1921, there was levied and assessed for said improvement upon certain premises belonging to the Forrest Realty Company, certain assessments as follows: Lot Number Five (5) of Stanbery Place Addition in the Village of Bexley, Ohio, the sum of \$276.11, of which amount \$192.96 represented a service assessment, and \$83.15 represented an area assessment; Lot Number Sixty-one (61) of Stanbery/^{Place} Addition in the Village of Bexley, Ohio, the sum of \$243.87, of which amount \$175.00 represented a service assessment and \$67.87 an area assessment, and

WHEREAS, prior to the levying of said assessments said, The Forreset Realty Company, had constructed under agreement with the Village of Bexley certain sanitary sewers for the service of said premises, and said assessments hereinabove set forth did not take into consideration the fact that said lots were already provided with adequate sewerage, for which reason, said assessments in so far as said service assessment is concerned should not have been levied upon said lots, and

Whereas, said assessments remain unpaid and interest has accumulated to the extent of \$120.68 as to said Lot Number Five (5); and \$104.78 as to said Lot Number Sixty-one (61), and, whereas, Council is of the opinion that said premises should be relieved from that portion of said assessments designated as service assessments, and proportionate amount of said interest, NOW, THEREFORE:

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BEXLEY, STATE OF OHIO:

Section 1. That there be, and there hereby is stricken from the assessment against said Lot Number Five (5) of Stanbery Place Addition the sum of \$192.96 and \$84.33 interest, and that there be and hereby is stricken from said assessment on Lot Number Sixty-one (61) the

sum of \$175.00 and \$75.18 interest; and that the County Auditor of Franklin County, Ohio, be and hereby is authorized and directed to strike said amounts of assessment and interest from his duplicate.

Section 2. That the Clerk certify a copy of this ordinance to the County Auditor of Franklin County, Ohio.

Section 3. This ordinance shall take effect and be in force from and after the earliest period allowed by law.
