AN ORDINANCE NO. 1050,

Determining to proceed with the construction and installation of a system of lighting for Astor Avenue between College Avenue and Pleasant Ridge Avenue, in the Village of Bexley, Ohic.

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BEXLEY, STATE OF OHIO:

Section 1. That it is hereby determined to proceed with the construction and installation of a system of lighting for Astor Avenue between College Avenue and Pleasant Ridge Avenue, in the Village of Bexley, Ohio, by laying under ground cables, erecting iron light standards, installing lamps, conduits and other necessary equipment, in pursuance of a Resolution No. 831, declaring it necessary to provide for lighting said street, adopted on the lith day of February, 1930, and in accordance with the plans, specifications, estimates and profiles for said system of lighting how on file in the office of the Village Clerk, which are hereby approved.

Section 2. That all claims for damages resulting from the construction and installation of said lighting system shall be judicially inquired into after the completion thereof, and the solicitor te and hereby is authorized and directed to institute proceedings in a court of Competent Jurisdiction to inquire into such claims.

Section 3. That the entire cost of constructing and installing said system for lighting said street, except one-fiftieth (1/50) thereof, and the cost of intersections, shall be specially assessed in proportion to the benefits which may result from said improvements on all the lots and lands bounding, fronting and abutting upon said proposed improvement between the points afor esaid, which said lots and lands are hereby determined to be specially benefited by said improvement, and in an amount equal to that part of the cost thereof hereby determined to be assessed thereon.

Section 4. That the special assessments so to be levied shall be paid in five substantially equal annual installments with

interest on the deferred payments at the same rate as shall be borne by the bonds to be hereafter issued in anticipation of the collection of said special assessments.

Section 5. That money shall be borrowed and the notes of said Village issued therefor in an amount not to exceed the estimated cost of said improvement due and payable not later than two years from the date of issue, in anticipation of the levy of said special assessments, and of the issuence of honds in anticipation of the collection of said special as comments.

Section 6. That bonds of said villings shall be issued in anticipation of the collection of said special assessments, in an amount sufficient to pay that portion of the estimated cost of said improvement for which said assessments are levied.

Section 7, That the remainder of the cost of said improvement shall be paid from the proceeds of bonds of said Village issued in the manner provided by law.

Section 8. That the Clerk of said Village be, and hereby is, authorized and directed to advertise for bids for the construction and installation of said system of lighting in the manner provided by law.

Section 9. This ordinance shall take effect and be in force from and after the earliest period allowed by law.
