

## ORDINANCE NO. 1076.

To establish the grade of curbs and sidewalks on Powell Avenue from Westland Avenue to Dawson Avenue and the grade of sidewalks on Powell Avenue from Dawson Avenue to Cassady Avenue.

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BEAKEY, STATE OF OHIO:

Section 1. That the permanent grade of the curbs of Powell Avenue from Westland Avenue to Dawson Avenue shall be and the same is hereby established as follows; and sidewalks and future improvements shall be constructed with reference thereto, to-wit:-

NORTH CURB: Between Westland Avenue and Dawson Avenue.

Beginning at Station 0+00, at the east property line of Westland Avenue, at Elevation 103.18; thence, with a 1.0% ascending grade, to Station 2+41.9, the end of the curb return at the west side of Parkview Avenue, at Elevation 105.50; thence, to the curb return on the east side of Parkview Avenue, Station 3+21.9, Elevation 105.58; thence easterly, on a 0.51% ascending grade to Station 8+21.9, the west curb return of Columbia Avenue, Elevation 108.11; thence, to the end of the curb return on the east side of Columbia Avenue, to Station 9+01.9, Elevation 108.68; thence easterly on a 0.654% ascending grade to the end of the curb return at the west side of Drexel Avenue to Station 14+02.2, Elevation 111.95; thence to the end of the curb return on the east side of Drexel Avenue at Station 14+82.2, Elevation 111.90; thence easterly on a 0.30% ascending grade to Station 15+75 and Elevation 112.18; thence on a vertical curve with the following station and elevations:

Station 16+00	Elevation 112.21
" 16+25	" 112.15
" 16+50	" 112.00
" 16+75	" 111.77

the end of the vertical curve; thence, continuing easterly on a 1.12% descending grade to Station 19+14.55, the end of the curb return at the west side of Dawson Avenue, Elevation 109.35. The location of the sidewalk shall be eighteen inches from the back edge of the curb and shall slope upward toward the property line at the rate of 3/8 inch per foot.

SOUTH CURB: Between Westland Avenue and Dawson Avenue.

The grade of the south curb shall be the same as for the north curb.

SIDEWALK GRADE: Between Dawson Avenue and Cassady Avenue.

The location and elevation of the edge of the sidewalk nearest the lot line on both the north and south sides of the street shall be one (1) foot from the lot line and five and one-half (5-1/2) inches above the grade of the existing curb.

The above elevations shall be held to refer to Village Datum.

Section 2. This ordinance shall take effect and be in force from and after the earliest period allowed by law.
