

AN ORDINANCE NO. 1093.

Authorizing the Board of Trustees of Public Affairs to enter into a contract on behalf of the Village of Bexley with the City of Columbus for supply of water for the period of one year from April 1st, 1931.

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BEXLEY, STATE OF OHIO:


Section 1. That the Board of Trustees of Public Affairs, through its president and clerk, be, and hereby is authorized to enter into a contract on behalf of the Village with the City of Columbus, for supplying water to the Village and the inhabitants thereof for the period of one year beginning April 1st, 1931, on substantially the following terms and conditions: That said city shall supply said Village with surplus water from the water works and filtration plant of said city by delivering such water to said Village in cast iron pipes furnished and laid by said village at its own cost and expense under Alum Creek and such streets of said city and said Village and at such intersections of water mains of said city as may be designated by the superintendent of the division of water of said city, such water to be measured by meters of a type and capacity designated by the director of public service of said city, and said contract to further provide that all mains, pipes, meters, services and mechanical connections for conducting such water supply shall be furnished, installed and maintained by said village at its own cost, but in conformity with the plans therefor to be submitted to and approved by the director of public service of said city and under his supervision, but the said village is not thereby to be relieved of responsibility for the proper installation and maintenance, or create any liability on part of said city, and further providing that said village shall have the right to use said water for all municipal purposes and to supply same to the inhabitants thereof and also to persons in the vicinity of said village upon reasonable terms, it being provided in said contract that the furnishing of water to persons outside of said village shall be upon terms and conditions subject to the approval and control of said director of public service of said city and the city council, and further that said city shall

not be liable to said village or its inhabitants or water consumers for failure or shortage of water supply; that said meters shall be read and the volume of water supplied to said village shall be computed on or about the first days of April and October in said year, and that payment shall be made therefor by said village to the cashier of the division of water of said city within thirty days after the reading of said meters and the rendering of a bill therefor, at the same rate, plus ten per cent, as that charged to resident consumers of said city, as is now fixed or as may hereafter be fixed by ordinance of the city council. It being further provided that upon failure to pay for said water consumed as provided herein the city shall have the right to cut off the water supply and said contract shall cease and terminate.


Section 2. Whereas, the Village of Bexley, under the provisions of law, will be officially classified as a City from and after the first day of January, 1931. This contract, if entered into, subsequent to said date shall be executed in the name of the City of Bexley, and the obligations of said contract shall extend to and be binding for the full term thereof upon said municipality of Bexley, whether entered into prior or subsequent to said first day of January, 1931.

Section 3. That this ordinance shall take effect and be in force from and after the earliest period allowed by law.
