Providing for the purchase of the land necessary to extend Mound Street from College Avenue to Sheridan Avenue.

Whereas, Edward R. Reeves and Alice R. Reeves, being the owners of a tract of two and one-half (22) acres off of the north side of Lot Number 1 of John Hikes' Amended Subdivision, formerly belonging to the SouthernOhio Public Service Company, and

Whereas, it is desirable that the City of Bexley acquire a portion of said tract, being 50 feet off of the north side of that portion of said tract which lies between College Avenue and Sheridan Avenue, to extend Mound Street between said College Avenue and Sheridan Avenue a distance of approximately 377 feet, and the said Edward R. Reeves and Alice R. Reeves have offered to sell the same to said City for the consideration of Two Thousand Dollars (\$2000.00), and upon the agreement of the City to pave said Mound Street between said points hereinabove specified at its own cost and without cost to the adjoining property owners, NOW, THEREFORE:

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO:

Section 1. That said City of Bexley does hereby accept said proposal of the said Edward R. Reeves and Alice R. Reeves to purchase said parcel 50 feet in width off of the north side of that portion of said two and one-half (2½ acre tract of land, hereinabove described, which lies between College Avenue and Sheridan Avenue, for said sum of Two Thousand Dollars (\$2000.00), which said sum of Two Thousand Dollars (\$2000.00) is hereby appropriated for said purpose from the Contingent Fund in the General Fund and hereby agrees that said portion of Mound Street shall be improved at the City's expense and without cost to the adjoining property owners.

Section 2. That the proper officials are hereby authorized to issue the voucher of the City for the purchase price of said premises upon the delivery of an abstract of title showing title

in said owners, free and clear from all encumbrances, except taxes for the year 1931, together with their warranty deed for said premises, all to the approval of the solicitor.

Section 3. That this resolution shall take effect and be in force from and after the earliest period allowed by law.
