

ORDINANCE NO. 15-31

By Mr. F. Bonnet.

To levy special assessments for the improvement of a portion of Gould Road, Main Street and Maryland Avenue, by constructing water lines therein.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO:

Section 1. That the assessment of the cost and expense of improving a portion of Gould Road, Main Street and Maryland Avenue, by constructing water lines therein, pursuant to and in accordance with an Ordinance No. 683, determining to proceed with said improvement, passed February 10th, 1926, in the aggregate amount of \$5800.00, as reported to this council on the 23rd day of December, 1930, by the board heretofore appointed to estimate said assessments, notice of the filing of which assessments has been given as required by law, be and the same is hereby adopted and confirmed, and that there be and is hereby levied and assessed upon the lots and lands bounding and abutting upon said improvement, the several amounts reported as aforesaid, which said assessments, together with the description of said lots and lands are as follows, to-wit:

And it is hereby determined and declared by this council that said lots and lands are each benefited by said improvement in an amount equal to the assessment hereby levied thereon and that said assessments are in proportion to the special benefits.

Section 2. That the total assessment against each lot or parcel of land shall be payable in cash within thirty days from and after the passage of this ordinance, or, at the option of the owner, in five annual installments, with interest thereon from the 1st day of March, 1931, at the same rate as shall be borne by the bonds to be issued in anticipation of the collection of the same, to-wit, the rate of _____ per centum per annum. All cash payments shall be made to the Treasurer of said City. All assessments and installments thereof remaining unpaid at the expiration of said thirty days shall be certified by the clerk of this council to the Auditor of Franklin, County, Ohio, as provided by law, to be by him placed on the tax duplicate and collected as other taxes are collected.

Section 3. This ordinance shall take effect and be in force from and after the earliest period allowed by law.
