RESOLUTION NO. 18-31.

Correcting omission in execution of bond herein described by authorizing signing of same by Mayor.

Whereas, under authority of a vote of the electors of the Village of Bexley, held on the 27th day of April, 1920, and pursuant to an Ordinance No. 240, duly passed by the Council of said Village on the 11th day of May, 1920, said Village issued its bonds in the principal sum of \$15,000.00 for the purpose of paying the cost and expense of constructing water lines in said Village, said bonds being numbered from 1 to 15, inclusive, each in the sum of \$1000.00, bearing interest at the rate of 6% per annum, payable semi-annually, on the 1st day of April and October of each year, as evidenced by the coupons thereto attached, said bonds bearing date of April 1st, 1920, and maturing on the 1st day of April, 1935, and

Whereas, in the execution and delivery of said bonds the Mayor of said Village of Bexley, inadvertently omitted to sign bond No.2 of said issue of bonds, althouthe same was duly signed by the Clerk, and the coupons thereto attached bore the facsimile signature of the Clerk, and

Whereas, said entire issue of bonds, including said bond No.2, was purchased by the Trustees of the Sinking Fund of said Village of Bexley for not less than par and accrued interest, and all of said bonds, including bond No.2, were delivered to said Trustees of the Sinking Fund, and were subsequently sold by said Trustees of the Sinking Fund to the BancOhio Securities Company, a bona fide purchaser thereof, and

Whereas, the person who, at the date of the execution and delivery of said bonds, was the Mayor of said Village of Bexley, is no longer such Mayor, but is now deceased, and

Whereas, it is the sense of Council that said omission of said Mayor to sign said bond No.2 should be corrected, and that same should be further executed on behalf of the City of Bexley by its present Mayor, said execution to be effective as of the date of said bond, to-wit: the lst day of April, 1920, NOW, THEREFORE,

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO:

Section 1. That said bond No.2, in the sum of \$1000.00, being one of a series of fifteen bonds of like date and amount, issued by the

Village of Bexley for the purpose of paying the cost and expense of constructing water lines in said Village, under the authority hereinabove recited, is, and the same is hereby declared to be, the valid and legal obligation of the City of Bexley, and the Mayor is hereby authorized and directed on behalf of the municipality to sign his name thereto as such Mayor, such signing to be affective as of the 1st day of April, 1920, in all respects as fully and completely as if executed by the Mayor of said municipality on that date.

Section 2. This resolution shall take effect and be in force from and after the earliest period allowed by law.
