ORDINANCE NO. 24-32

Providing for entering into an agreement with the City of Columbus, Ohio, for supply of water for the period of one year from April 1st, 1932.

Whereas, the contract of the City of Bexley with the City of Columbus, Ohio, for the supply of water to the City of Bexley and inhabitants thereof, will expire on the 1st day of April, 1932, and

whereas, it is deemed to be for the best interests of said respective municipalities that a contract shall be entered into with said City of Columbus for such supply of water for a further period of one year, NOW, THEREFORE:

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO:

Section 1. That the Mayor be and he is hereby authorized, to enter into a contract in the name of and on behalf of the City of Bexley with the City of Columbus for the supplying of water by said City of Columbus to the City of Bexley, and the inhabitants thereof, for the period of one year beginning April 1st, 1932, on substantially the following terms and conditions:-

That the City of Columbus shall supply the City of Bexley with surplus water from its water works and filtration plant by delivering such water to said City of Bexley in cast iron pipes furnished and laid by Bexley at its own cost and expense in such streets and at such intersections of water mains of said City of Columbus as may be designated by the Director of Public Service of said City, such water to be measured by meters of a type and capacity designated by said director; and said contract to further provide that all mains, pipes, meters, services and mechanical connections for conducting such water supply shall be furnished, installed and maintained by said City of Bexley at its own cost, but in conformity with the plans therefor to be submitted to and approved by the Director of Public Service of said City of Columbus and under his supervision, but said City of Bexley is not thereby to be relieved of responsibility for the proper installation and maintenance,

or create any liability on the part of the City of Columbus; said contract shall further provide that said City of Bexley shall : have the right to use said water for all municipal purposes and to supply same to the inhabitants thereof and also to persons in the vicinity of said City upon reasonable terms, it being provided in said ∞ ntract that the furnishing of water to persons outside of said City of Bexley shall be upon terms and conditions subject to the approval and control of said Director of Public Service of Columbus and the City Council, and further that said City of Columbus shall not be liable to said City of Bexley or its inhabitants or water consumers for failure or shortage of water supply; that said meters shall be read and the volume of water supplied shall be computed on or about the first days of April and October in said year, and that payment shall be made therefor by the City of Bexley to the Cashier of the Division of Water of Columbus within thirty days after the reading of said meters and the rendering of a bill therefor, at the same rate, plus ten per cent, as that charged to resident consumers of the City of Columbus, as is now fixed or as may hereafter he fixed by ordinance of the Columbus Council. Said contract shall further provide that upon failure to pay for said water consumed as provided herein, the City of Columbus shall have the right to cut off the water supply and said contract shall cease and terminate.

Section 2. This ordinance is an emergency ordinance and is necessary for the immediate preservation of the public health and safety, said emergency being that the existing contract for water supply will expire April 1st, and this ordinance shall go into immediate force and effect.
