BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO:

Section 1. That said sum of \$13.70, being the two installments of said sewer assessment heretofore paid by the said Jacob W. Schaefer by mistake be refunded to the said Jacob W. Schaefer from the Sinking Fund, and the proper officials be and the same are hereby authorized and directed to execute the necessary voucher therefor.
