ORDINANCE NO. 44-32

By Mr. Wheaton.

To levy special assessments for the improvement of Main Street from the east line of Euclaire Avenue to Gould Road

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO:

Section 1. That the assessment of the cost and expense of improving Main Street (Being State Route #1) from the east line of Euclaire Avenue to Gould Road by grading, draining, curbing and paving the roadway thereof with brick, asphalt, with brick gutters, or concrete, erecting street signs, moving light cables relocating ornamental light standards and erecting new ornamental light standards pursuant to and in accordance with a resolution of council adopted June 9, 1931, proposing to cooperate with the Director of Highways of the State of Ohio, in the making of said improvement and in accordance with resolution #33-31 declaring it necessary to make said improvement, adopted June 30, 1931 and also in accordance with and pursuant to Ordinance No. 58-31 determining to proceed with said improvement, passed July 16th, 1931, in the aggregate amount of \$24,800.00 as reported to this Council on the 6th day of May, 1932 by the Board heretofore appointed to estimate said assessments, notice of the filing of which assessments has been given as required by law, be and the same is hereby adopted and confirmed, and that there be and there is hereby levied and assessed upon the lots and lands bounding and abutting upon said improvement the several amounts reported as aforesaid, which said assessments, together with the description of said lots and lands are as follows, to-wit:

And it is hereby determined and declared by this Council that said lots and lands are each benefitted by said improvement in an amount equal to the assessment hereby levied thereon and that said assessments are in proportion to the special benefits.

Section 2 - That the total assessment against each lot or parcel of land shall be payable in cash within thirty days from and after the passage of this ordinance, or, at the option of the owner, in nine annual installments, with interest thereon from the 1st day of September, 1932, at the same rate as shall be borne by the bonds to be issued in anticipation of the collection of the same, to-wit: the rate of 6 per centum per annum. All cash payments shall be made to the Treasurer of said City. All assessments and instalments thereof remaining unpaid at the expiration of said thirty days shall be certified by the clerk of this Council to the Auditor of Franklin County, Ohio, as provided by law, to be by him placed on the tax duplicate and collected as other taxes are collected.

Section 3 - This ordinance shall take effect and be in force from and after the earliest period allowed by law.
