ORDINANCE NO. 3-33

By Mr. Pretzman.

To amend Section 5 (a) of Ordinance No. 93-51, establishing administrative departments for the City of Bexley.

BE IT ORDAINED BY THE COURCIL OF THE CITY OF BEXLEY, STATE OF OHIO:

Section 1. That Section 3 (a) of Ordinance No. 93-51, establishing administrative departments for the City of Bexley, passed December 22nd, 1951, be and the same is hereby amended to read as follows:

Section 3 (a). The Division of Police, or Police Department, shall be composed of the following officers and other members who shall receive the respective salaries hereinafter provided.

- (1) A Chief of Police, who shall be appointed by the Mayor and confirmed by council for a term of one year, and until his successor is appointed and qualified. He shall receive a salary of \$2400.00 per annum, payable monthly.
- (2) A Police Sergeant, who shall be minted by the Mayor from the ranks of the patrolmen.

 The shall receive a salary of \$2100.00 per annum, payable such Sergeant may be reduced to the rank of a at the pleasure of the Mayor, in which event way shall be governed by paragraph (3) hereof.
- (3) Six Patrolmen, who shall be appointed by the Mayor from lists submitted by the Civil Service Commission in accordance with law. The salaries of said patrolmen shall be dependent upon their length of service, and shall be as follows, to-wit:

For the first year \$1680.00 per annum, payable monthly, For the second year and thereafter \$1980.00 per annum, payable monthly,

Provided, however, such persons as have been continuously in the service of the municipality for two years next preceding the first day of January, 1932, may be appointed to this Department to serve until discharged, reduced, promoted or transferred in accordance with the provisions of the Charter. The duties of the Chief and other members of the Department shall be as prescribed by the Charter and the statutes of Ohio, or by ordinance of Council hereafter enacted. They shall also serve notices and enforce the rules and regulations of the Board of Health and other Boards, as directed by the Mayor, and shall maintain and keep in good condition all police automobiles, motorcycles, radios, and other equipment used by this Department. They shell also perform such duties in connection with the Fire Department as may be required by the Mayor or Chief of the Fire Department until otherwise provided by ordinance.

Section 2. That said Section 5 (a) of Ordinance No. 95-51, be and the same is hereby repealed.

Section 3. This ordinance is an emergency ordinance and is necessary for the immediate preservation of the public health and safety, and shall go into immediate effect.
