Authorizing the Mayor to execute applications for work relief projects and authority to pay relief labor in cash.

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO:

Section 1. That the Mayor be and he hereby is authorized to execute applications for approval of work relief projects, and authority to pay relief labor in cash for the following proposed projects within the City of Bexley, Franklin County, Ohio, to-wit:

- 1. A relief sanitary sewer extending from end of present Columbia Avenue relief sewer to Dawson Avenue by way of Dale Avenue to relieve termitory between Dawson and Cassady from Fair Avenue to Seneca.
- 2. Mound Street grading and paving from Sheridan Avenue to College Avenue.
- 3. Mound Street grading and surfacing, possibly cinders or gravel from Euclaire to Chelsea.
- 4. Powell Avenue grading from Parkview to Dawson and resurfacing with cinders or gravel from Westland Avenue to Dawson Avenue.
- 5. Powell Avenue grading from Cassady Road to Gould Road. This portion of Powell Avenue improvement should be of a permanent nature by putting on surface of water-bound macadam.
- 6. Elm Avenue from Columbia to Dawson grading and resurfacing.
- 7. Dale Avenue from Westland Avenue to Dawson should have the present surface repaired, if not all ready done, and from Cassady Road to Cassingham should be graded and resurfaced.
- 8. Westland Avenue from Bryden Road to Fair Avenue -- trees should be graded out, the pavement should be centered by possibly widening the present pavement with macadam if the present pavement is not too far off center.

In addition to the pavement and grading a sanitary sewer should be constructed from Parkview Avenue to Westland Avenue in Bryden Road and thence, northerly in Westland Avenue.

- 9. Cassingham from Ruhl to Maryland should be braded out and surfaced to provide outlet for the residents in Bellwood Addition by way of the present improved street to Broad Street.
- 10. Astor Avenue from College to Pleasant Ridge
 Avenue -- the trees should be removed, the
 light standard set brok and the macadam pavement
 centered on the street. This possibly will require some small amount of grading.
- 11. Charles Street from Sheridan Avenue to College
 Avenue, and from Euclaire Avenue to East corporation line, should be graded out and surfaced.
- 12. Pemington Road from Fair Avenue north to school property should be graded and surfaced.
- 13. The Fair Avenue and Remington Road intersection should be provided with some adequate plan of drainage to get rid of the water which stands at the end of the Fair Avenue pavement.
- 14. A sanitary relief trunk sewer should be constructed from Main to Livingston along the right of way of present truck sewer which is now inadequate in size. As an alternate plan this new relief sewer could be extended southerly for such distance that it could be carried across Alum Creek and into City of Columbus trunk sewer.
- 15. Gould Road macadam pavement from Main Street to Bread Street; should be reshaped and possibly widened in some portions. This would possibly need to be a joint project with the City of Columbus as the corporation line of Columbus and Bexley is on the center of this road.

- 16. Francis Avenue this street could be graded and the drainage and sanitary sewers could be constructed provided the City of Bexley has acquired all the necessary right of way from Livingston Avenue to Mound Street.
- 17. Pleasant Ridge Avenue this street, like
 Francis Avenue, could be graded and the sewers
 constructed providing the City owns all the
 necessary right of way.
- 18. Drainage for various alleys which have been requested in the past few years could be handled through this program.
- 19. Drexel widening Powell to Broad.
- 20. Clifton resurfacing.
- 21. Round corners on Main Street.
- 22. Remington, Main to Fair.
- 23. Sidewalk south side Main.
- 24. Maryland east of Cassady clearing.
- 25. Pleasant Ridge Mound Street south.
- 26. Denver grading Cassady east.

Also such other projects as may be hereafter decided upon by the Council.

section 2. This resolution is an emergency measure and necessary for the immediate preservation of the public peace, health and safety in that large numbers of citizens are unemployed, and it is necessary that said projects be gotten under way without delay, for which reason said resolution shall go into immediate force and effect.
