

ORDINANCE No. 16-33

Adopting statement providing for expenditure of gasoline tax monies for work or poor relief.

Whereas, the Council of the City of Bexley, Ohio by Ordinance No. 15-33, duly passed May 9th, 1933, found that it will be necessary to expend from gasoline tax monies allocated, or to be allocated, to the City of Bexley, during the year 1933, for work and poor relief during said year the following sums, to-wit: for direct relief \$1000.00, and for work relief \$7000.00, and therein directed the Auditor to file in his office two or more copies of a statement in the form prescribed by the State Relief Commission of the amount proposed to be so expended, and the particular type or types of relief proposed to be rendered, and also therein directed that notice of a public hearing upon the adoption of said statement be held on the 23rd day of May, 1933 at 7:00 o'clock P.M., and to give notice of said hearing not less than five days previous thereto by publication thereof in a newspaper having general circulation in the City of Bexley, and

Whereas, two copies of said statement were filed in the office of the Auditor for public inspection more than five days before its adoption, and

Whereas, publication has been had in the Ohio State Journal of a notice of public hearing upon the adoption of said statement on the 23rd day of May, 1933, at 7:00 o'clock P.M., and


Whereas, said public hearing was held at said time and in accordance with said notice, NOW, THEREFORE,
BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO:

Section 1. That the statement of the amount proposed to be so expended for work and poor relief in the following sums, to-wit: for direct relief \$1000.00, and for work relief \$7000.00, be and the same is hereby adopted, and that said sums, as same shall be received by said City, are hereby appropriated for said purposes.

Section 2. That the Clerk be and hereby is directed to certify a copy of each of the following to the State Relief Commission, to-wit:- Ordinance No. 15-33, passed May 9, 1933; copy of statement of the amount proposed to be so expended and the particular type or types of relief proposed to be rendered, together with his certificate that two copies of same were filed in the Auditor's Office for public inspection not less than five days prior to the adoption thereof; proof of publication of notice of public hearing upon the adoption of said statement; Ordinance No. 16-33, passed May 23rd, 1933.


Section 3. This ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety; the reason for such necessity lies in the fact that said condition of wide spread unemployment and necessity for relief require the immediate expenditure of gasoline tax funds for poor relief purposes; therefore, this ordinance shall go into immediate effect.


